**Minutes of the Annual General Meeting  
of the Swiss Society of New Zealand (Inc.), held at the  
Cosmopolitan Club, Hamilton, on 3rd June, 2001**

**Meeting opened:** 2.00pm

**Welcome:** The Society President, Beatrice Leuenberger, opened the meeting, welcoming everyone to Hamilton. Beatrice congratulated the Taranaki Club for once again winning the annual Cowbell Competition final against Auckland that morning. She also thanked the Hamilton Committee for organising the competition final, and providing a delicious morning tea and lunch.

These are gained through the Clubs directly, the web site, and the letter the Embassy sends to new registrations - as well as by 'word of mouth'. If anyone knows, or happens to meet, someone Swiss, please tell them about the Society and Clubs. Even if they don't join a Club, they can still become Society members and receive the *Helvetia*. Thanks also to all the Clubs for their perseverance in the collection of subs from Club members.

Over the past year we have attempted to run competitions and activities for younger members, and it is unfortunate that the response hasn't been fantastic. I'd like to ask parents to encourage children to take part in future activities and get them involved in reading the *Helvetia* - after all, they are tomorrow's members. Once again, I'd like to thank the Society committee for their input in running the Society. Thanks in particular our Editor, Rinaldo Rust, for the large amount of work, time, effort in producing our magazine - this on-going commitment is much appreciated by many.

**Financial Report:** (Beatrice Leuenberger reported) Copies of the financial report were circulated for everyone to read. Excess Income of \$1,382 plus \$1,686 ('700 years Switzerland' funds raised in 1991 and previously held by Embassy) increased our accumulated funds to total \$31,627. A good portion of income is through advertising, and we again urge all members to support our advertisers.

**Delegate for Swiss Abroad's Report:** (Heinz Leuenberger reported) The Swiss Revue is a good source of information about economic and political issues. Also talked on the merits of voting in the Swiss elections or referenda, and the role of the Swiss Abroad Organisation. The Report was moved for adoption.

**Riflemaster's Report:** (Peter Rust reported) Events during the past year took place without any problems. It was good to see so many juniors take part - these are the 'cowbell holders' of tomorrow! Medals are still partially subsidised, and a net loss of nearly \$200 was recorded. The Riflemaster's account balance is now \$1,277. The low NZ dollar has effectively increased the cost of medals. The Report was moved for adoption.

**Setting of Subscriptions 2001 / 2002:** (Beatrice Leuenberger reported) Thanks to advertisers for their continued support. The actual cost per membership would be about \$35, so without advertising, subscriptions would be much higher. We are also very aware of costs and try very hard to keep expenses down. The committee could see no reason to increase the subscription and recommended that the fee once again be set at the current cost of \$25 per household.

## General Business:

1. Club Reports: Club Presidents were invited to report on Club activities over the past year.

*Hamilton - Herbert Staheli* Good support at functions, especially the six card evenings during the Winter months. Membership numbers remains steady at about 123 (households).

*Taranaki - Walter Seifert* Functions also well attended. Membership is currently about 250 (people).

*Wellington - Roland Schütz* Pleased with the work on the new Clubhouse, but still a lot to be done on the outside. Roland invited everyone to Wellington for a working bee! Mrs Ruth Messmer has been the Club's Treasurer for 57 years. Membership is currently about 100 (people).

*Auckland - Uli Kipfer* Power is now connected at the Clubhouse. Still lots of work to be done at the farm. Membership is about 130 (households).

2. Web Page: Heinz Matysik talked about the importance for Clubs to have a web page, but it has to be regularly updated - each club named a person responsible for updating information... Auckland - Heinz Matysik; Taranaki - Markus Rufer; Hamilton - Anna Rufer; Wellington - Lotti Napp. Clubs are responsible for their own information.

*Cost of web page:* It was suggested that the \$250 cost of maintaining the web site be taken over by the Society, also using the interest from the '700 year fund'.

3. Medal Competitions: The method of calculation for sports' medals was queried and discussed. Medals are given to the top 20% of placings, so sometimes more are awarded if the last qualifying placing has multiple winners. It was preferred to award 'more rather than less' medals. Rules are available on request, and all clubs were sent copies about five years ago.

4. Swiss Flag: It was discussed how to go about preventing the misuse of the Swiss Cross for advertising and labelling purposes. The Swiss Embassy would probably know more about this, and should be notified of any misuse discovered.

**Venue for next Meeting:** Taranaki Club President, Walter Seifert, invited all members of the Swiss Society to meet in Kaponga at Queen's Birthday Weekend, 2002, where the Taranaki Swiss Club would be pleased to host the next Annual General Meeting. This would also coincide with the host Club's 50th Anniversary.

**Meeting Closure:** On behalf of the Society, Beatrice accepted the invitation from the Taranaki Swiss Club to host the next meeting, and sincerely thanked and congratulated the Hamilton Club committee and members for a very well organised and successful AGM weekend.

Finally, Beatrice thanked all members present for their attendance and participation, and wished everyone an enjoyable evening function and a safe journey home.

The 2001 Annual General Meeting was closed at 3.45 pm.
