# Editorial

Well ..., I say!!! Talk about the hound (the Governments' own legislation) turning around and biting its' master in the ---, backside!!!

I always thought everyone is entitled to New Zealand Super on reaching 65 years of age, and working for a New Zealand employer, inside or outside New Zealand, as long as they are New Zealand citizens and pay income tax to the New Zealand Government. Apparently I was very wrong!!! Apparently there exists a reciprocal agreement between the New Zealand and British governments regarding super payments to each others' superannuitants while living in each others' country, similar to the agreement with Australia and maybe one or two other countries as well, but not Switzerland, as far as I'm aware of at present.
