## AHV matters

*Heinz Leuenberger wrote to the Rt Hon Winston Peters, Associated Minister for Senior Citizens, regarding AHV/NZ Superannuation, and he got the following letter back:*

Dear Heinz Leuenberger

Thank you for your letter of 16 May 2007 regarding overseas pensions.

As you will be aware, New Zealand First secured the government's agreement to investigate ways to improve options for senior citizens who may be eligible for foreign pensions as well as New Zealand Superannuation, as part of its Confidence and Supply Agreement.

New Zealand First is committed to this initiative and has been engaged in a number of discussions with the government on this front. During these discussions we have considered a range of options in administering overseas pensions, eligibility issues and the impact of spouses on entitlements, as examples, along with the nature of our international agreements, and a wide range of pension related matters.

The government is well aware of New Zealand First's firm resolve to address these matters, however they are by nature complex and multifaceted, and take time to progress. That said, progress is being made and we expect a cabinet paper addressing several aspects of this policy to be submitted in the near future.

However, the responsibility of overseas pensions and associated matters ultimately falls upon Hon David Benson-Pope, Minister for Social Development and Employment, to resolve as part of his portfolio. For this reason I have referred a copy of your letter to Mr Benson-Pope's office for his information.

In conclusion, it is our desire to see some real action on the portability of pensions, and you can be assured New Zealand First remains committed to honouring the undertakings contained within the Confidence and Supply Agreement.

Once again thank you for taking the time to share your views on this important issue.

## Swiss Casinos and Lotteries have a Jackpot Year

The Swiss spent more on lotteries and gambling in 2006 than ever before, parting with SFr 2,8 billion. The casinos' profits (SFr 955 million) were higher than the lotteries in 2006 for the first time.

Under Swiss law, all profits made from gambling and lotteries are turned over for social or public utility causes. No less than SFr 586 million was transferred to cantonal lottery and sports funds, as well as sporting associations. Switzerland's 19 casinos paid a total of SFr 495 million in taxes last year, funds that were used mainly to prop up the national pension system.
