## Treasurer's Report (Sandrine Smith)

from 31 March 2017

The accounts have been audited in May 2017. The Swiss Society of New Zealand has made a net profit of \$453 compared to \$567 for the year ending 2016. Six issues of the Helvetia were produced and sent out at an average cost of \$2,408 (last year \$2,421) per issue. The Society has approximately 588 paying members: Society only: 75; *Auckland Club*: 145 – incl. 4 honorary; *Hamilton Club*: 139 – incl. 7 honorary; *Taranaki Club*: 186 – incl. 1 honorary; *Wellington Club*: 59 – incl. 4 honorary. **Total = 588 members.** Advertising revenue is \$500 lower than the previous year. This is due to some misunderstanding which has now been addressed. All account receivables and payables have been paid for the year ending 2017. Accumulated funds increased from \$70,822 in the prior year to \$71,376 in the current year. Thank you to the Clubs' treasurers for helping me.

## Rifle master's Report (Manuela Epp)

Statistics on participation: *Auckland*: 44 participants in 58 events / 16 medals (1 double, 1 triple); *Hamilton*: 53 participants in 64 events / 20 medals (1 double); *Taranaki*: 40 participants in 98 events / 19 medals (4 double, 1 triple); *Wellington*: 16 participants in 16 events / 6 medals. In Total 153 participants in 236 events / 61 medals, 10 stars i.e. total of 71 awards (same as last year).

## Delegate for Swiss Abroad Report (OSA), Peter Ehrler.

- Automatic Exchange of information and Section 70 have been major big topics this year.

- Peter Canziani went to OSA meeting in Switzerland 2016 and both will go this year to OSA in Basel.

- In October 2016 Oceania conference was held and the launch of the Web-page to reach more people in AUS/NZ and Pacific Islands. Oceania conference was initiated 4 years ago. 2018 Conference will be in Sydney – all presidents of Swiss Clubs invited. Australia doesn't have governing Body like we in NZ who have the Swiss Society – all clubs independent thus communication is difficult.

- Contact with political parties in NZ concerning Section 70 – met with Winston Peters arranged by Swiss Ambassador. Other countries facing same problems. If NZ First becomes a coalition partner at the next elections, coalition talks will include section 70 which has to be abolished. Total of 86,000 NZ residents same problem.

- Platform was given by the Ambassador to speak to Mr Gasser, State Secretary of Switzerland – before signing Joint Declaration regarding AEI. Mr Gasser promised that at every meeting he will attend, section 70 will be brought up.

- Beginning of year many people including Swiss Society have written letters protesting to Federal Council and political parties about Sec 70 and AEI and have received feedback.

- March this year Hungarian OSA delegate member had a motion wanting to go to court about the Swiss banks – withdrew the motion if OSA would take it on board and take it to court about not being able to have an account in Switzerland.

- NZZ approached Adrian Blaser about section 70 and pension problems in NZ. Passed on to Peter E – article has been published. 400'000 readers.

- National Council voted 81/79 against making banks accept Swiss abroad. Found out who voted and not – betraying the OSA. Sent heavy protesting letter to the Executive members of OSA

- Dr. David Vogelsanger, Juerg Bono and others at Embassy have worked hard to fight against section 70. Sincere thanks
