## Treasurer's Report (Sandrine Smith)

– read by Anita Zuber, from 31 March 2019  
The accounts have been reviewed by an independent party in May 2019. Based on the review, nothing has come to the reviewer's attention that caused him to believe that the financial statements didn't give a true and fair view of the financial position. The Swiss Society of New Zealand has made a net loss of \$841 compared to a net profit of \$1242 for the year ending 2018. Expense for the printing of the Helvetia has increased by 51.86%. The Treasurer recommends members to opt into subscribing to the digital issue. Expenses for conferences: \$1000 to Peter Ehrler for the 2018 OSA Conference, \$300 to Adrian Blaser and \$500 to Hans Vetsch for the Presidents Conference and \$1000 to Taranaki for hosting 2018 AGM. Sourced locally, the expense for the medals has decreased by 58.5%. The company Swiss airlines has sponsored \$720 instead of advertising. Six issues of the Helvetia were produced. The costs of the 6 issues were \$16,576. The income from the subscriptions and adverts were \$16,250. That represents a loss of \$326 for the year or \$55 per issue. If the company Swiss had advertised instead of sponsoring, the production would show a profit. The Society has 596 paying members as per 31 March 2019. Swiss Society: 60, Auckland 141 (7 honorary); Taranaki 202 (1 honorary); Wellington 61 (2 honorary). Total 596 – 2 more than last year.  
Matters arising: questions raised and answered about increase in printing costs, online Helvetias (maybe one quarter support this) and number of honorary members

**Update on 2020 Oceania Presidents Conference** – Hans gave an overview of what is planned and how this event will be funded. Deposit has been paid by Society for Novotel Ellerslie. If not enough sponsorship found

then it will be user-funded. Most clubs have promised some form of support (money, brunch, transport, music). Marianne queried how Society members benefit from this conference.

## Rifle master's Report (Manuela Epp)

– read by Hans Vetsch  
Statistics on participation: Auckland: 45 participants with 13 medal placings, last year 47 participants – down 2; Hamilton: 84 participants with 23 medal placings, 98 last year – 14 down; Taranaki: 91 participants with 26 medal placings, last year 93 – 2 down; Wellington: 27 participants with 8 medal placings, 19 last year – 8 up. In Total 247 participants, last year 257.

## Delegate for Swiss Abroad Report (OSA), Peter Ehrler.

- Hundreds of phone calls and emails received in last year, mostly queries on Section 70 and AIA
  - Attended Delegates Conference in Visp 10-12 August. Topics discussed were E Voting; Banks (Cantonal Bank of Geneva will let Swiss Abroad open an account); Swiss losing second passport
  - Busy lobbying parliamentarians and MPs
  - Luca Betti, an independent Swiss Italian journalist has been working on several articles
  - Will be attending OSA Delegates Conference in Montreux 18-20 August 2019
  - OSA 2020 summer conference will be in Lugano
  - Meeting with committee for 2020 Presidents conference in Auckland
  - Latest update – If your partner gets an overseas pension from 1 July 2020, your NZ Super won't be affected.

## Japonais

(Helen Staheli's specialty)

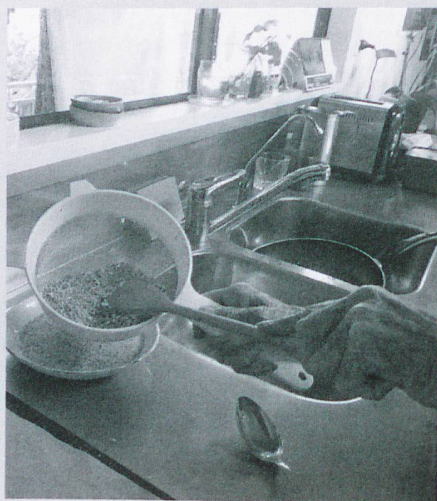
60g Hazelnuts finely ground  
4 Eggwhites  
160g Sugar  
1 tsp Vanilla Essence  
20g Flour

### Mocca Icing

160g Butter  
140g Icing Sugar  
½ cup strong coffee

### Sprinkle

40g Sugar  
40g Hazelnuts finely ground  
Chocolate buttons



Beat egg whites until stiff and fluffy. Add sugar, flour, vanilla essence and hazelnuts and gently mix together. Put in spoonfuls on baking tray covered with baking paper. For more even sizes spoon into a round cookie cutter. Bake on medium heat for about 25 minutes. Makes about 20.

For mocca icing soften butter and add icing sugar and coffee and mix to a smooth consistency.

Sprinkle can be done in advance. In a hot frypan melt sugar together with ground hazelnuts until brown and caramelised. Let the sprinkle cool off and then put through a fine grinder or crush to create fine sprinkles.

Coat each cookie with the mocca icing and dunk in a plate of sprinkles and add chocolate button. Keep in fridge until you're ready to eat them. Enjoy!!
