## President's Annual Report

### *Dear members*

It is hard to believe that its 5 years since I was approached to consider taking on the presidency of the Swiss Society for a four-year term. It was in Wellington at their clubhouse, having a good time with friends when someone, who shall remain nameless, conned me in to accepting this job.

- The committee made a commitment to host the 2020 Oceania presidents' conference here in New Zealand this year. Unfortunately this had to be postponed due to Covid 19 however we hope to be running it in October 2021.
- As a committee we reviewed the constitution and sports rules. This was not an easy task and it dragged on for two years. The main issue here was that we didn't follow what was written in the constitution and we felt that this had to be rectified .

This is my last report and I was hoping to go out on a high note. Sadly, Covid-19 threw a spanner in the works and we will not be able to get together this year for the AGM. Can I take the opportunity here to sincerely thank the whole team for what I believe was a job very well done and I look forward to handing this responsibility on to the Taranaki Club. I am convinced that they will do a tremendous job and I wish them well.
