Reviewer Report

To the members of the Swiss Society of New Zealand Incorporated (Swiss Society):

I have reviewed the accompanying financial statements of the Swiss Society for the year ended 31 March 2020.

Committee Responsibilities

The Committee are responsible for the preparation and fair presentation of these financial statements, and for such internal control as the Committee determines is necessary to enable the preparation of the financial statement that is free from material misstatement, whether due to fraud or error.

Reviewer's Responsibility

My responsibility is to express an independent conclusion on the accompanying financial statements. I have conducted by review in accordance with appropriate Review Standards. These Standards require me to conclude whether anything has come to my attention that causes me to believe that the financial statements are not prepared in all material respects in accordance with the applicable financial reporting framework.

A review of financial statements is a limited assurance engagement. The Reviewer performs procedures, primarily consisting of making enquiries of the entity as appropriate, and applying analytical procedures, and evaluates the evidence obtained. The procedures performed in a review are substantially less than those performed in an audit. Accordingly, I do not express an audit opinion on these financial statements.

Conclusion

Based on my review, nothing has come to my attention that causes me to believe that the financial statements do not give a true and fair view of the financial position of the Swiss Society for the year ended 31 March 2020.
