Guidelines to contributors of scientific articles

1. Articles for publication should be sent electronically to scientific.papers@actuaries.ch. Submission of an article is held to imply that it contains original unpublished work and is not being submitted for publication elsewhere. Receipt of an article will be confirmed and followed by an evaluation process.
The papers should be written in English, German or French.
2. The papers submitted should be structured as follows:
 - Actual text
 - Possible annexes
 - Bibliography
 - Abstracts in English, German, and French, the first of the abstracts being the one written in the language of the article.
3. The first page of each article must start with the author's name (or the authors' names), the place, and the title.
4. The bibliography must be placed at the end of the text. Authors must be listed in alphabetical order; publications of the same author, in chronological order. Publications of one author of the same year must be distinguished by letters a, b, c, etc. For journal references, give author or authors (in capitals), year, title, journal (in italics), volume (in bold type), and pages. For book references, give author/authors (in capitals), year, title (in italics), editor, and place.

Examples:

BARLOW, R. E. and PRISCHAN, F. (1975) *Mathematical Theory of Reliability and Life Testing*. Holt, Rinehart and Winston, New York.

JEWELL, W. S. (1975 a) Model variations in credibility theory. In *Credibility: Theory and Applications* (ed. P. M. Khan), 193–244, Academic Press, New York.

JEWELL, W. S. (1975 b) Regularity conditions for exact credibility. *ASTIN Bulletin* 8, 336–341.

References in the text are given in parentheses and should contain the author's name and the year followed by a letter, if expedient.

5. The address of at least one of the authors should be typed at the end of the bibliography.
6. Footnotes should be avoided as far as possible.
7. Instructions to the printer should be listed on a separate sheet entitled "Special instructions to the printer". (Examples of such instructions: Greek letters are indicated with green underlining; capital letters with a double underlining.)
8. Authors will receive from the printer two sets of page proofs together with the manuscript.
