ELISABETH BRONFEN is Professor of English and American Literature at the University of Zurich. She has written articles in the area of gender studies, psychoanalysis, literary and cultural theory. Her recent book publications are Over Her Dead Body: Death, Femininity and the Aesthetic (Manchester University Press) as well as Death and Representation, co-edited with Sarah W. Goodwin (Johns Hopkins University Press). She has a book forthcoming entitled Dorothy M. Richardson's Art of Memory: Space, Identity, Text, as well as The Knotted Subject, Hysteria and its Discontents.

ARMANDO COLOMBO is an assistant at the University of Zurich and currently writing a dissertation on Coleridge and the reader.

STEPHEN COPLEY is lecturer in English at the University of York. His publications include Literature and the Social Order in Eighteenth-Century England (1984), and essays on the eighteenth-century literature, aesthetics and polite culture. He is the joint editor of three collections of essays: Beyond Romanticism (1992); The Politics of the Picturesque (1995); and Adam Smith's Wealth of Nations: New Interdisciplinary Essays (1995).

TIM FULFORD is a fellow of Jesus College Cambridge. His publications include Coleridge's Figurative Language (1991) and – edited with Morton D. Paley – Coleridge's Visionary Languages: Essays in Honour of J. B. Beer (1993).

FRITZ GUTBRODT is an Assistant Professor at The Johns Hopkins University in Baltimore and Rektor of the Hochalpines Institut Ftan. He has mainly published on 19th-century English and European literature and is currently completing a book on authorship, translation, and plagiarism entitled *Joint Venture*.

PETER HUGHES is Professor of English and American Literature at the University of Zurich. His publications include V. S. Naipaul (Routledge), a poetic sequence, "Out of Europe" (Ploughshares and PN Review), and a number of intertextual studies – including the essay in this volume – that are parts of two forthcoming books, Allusion and Secrecy and Performing Theory: Shakespeare in Wittgenstein.

BRUCE LAWDER is the author of *Vers le vers*, a study of modern French, German and English prosody. He has published poems, stories, essays and translations in Switzerland, France, Germany, England and the United States. He teaches English literature at the University of Zurich.

J. C. C. MAYS is Professor of Modern English and American Literature at University College Dublin. He has written extensively on modern Irish and Romantic writers and is an editor for the *Collected Coleridge* and the *Cornell Yeats*. His three-volume edition of *Coleridge's Poems and Plays* should appear from Princeton University Press in 1996.

MORTON D. PALEY is a Professor in the Graduate School at the University of California, Berkeley, and co-editor of Blake: An Illustrated Quarterly. He is the author of a number of studies of literature and art of the Romantic period, including The Continuing City (1983), The Apocalyptic Sublime (1986) and Coleridge's Later Poetry (forthcoming in 1996). He has edited William Blake's Jerusalem (1991), Mary Shelley's The Last Man (1994) and (with Tim Fulford) Coleridge's Visionary Languages: Essays in Honour of J. B. Beer (1993). He is now writing on the Romantic Millennium.

ROBERT REHDER is Professor of English and American Literature at the University of Fribourg (Switzerland). He is the author of Wordsworth and the Beginnings of Modern Poetry (1981), The Poetry of Wallace Stevens (1988), Coleridge and Wordsworth: The New World of Imagination and an edition of A Narrative of the Life of Mrs. Charlotte Charke (both forthcoming). His volume of poetry, The Compromises Will Be Different, has just been published in Britain and the United States.

JONATHAN WORDSWORTH is Chairman of the Wordsworth Trust, Grasmere, and University Lecturer in Romantic Studies at Oxford. His books and editions include *The Music of Humanity, Bicentenary Wordsworth Studies*, the *Norton Prelude* (ed. with M. H. Abrams and Stephen Gill), *The Borders of Vision, Ancestral Voices, Visionary Gleam*, and the new Penguin Four-Text *Prelude*. To date he has 120 volumes in print in the facsimile reprint series *Revolution and Romanticism*.
