## Notes on Contributors

ROBERT CHODAT has degrees from McGill University in Montreal and is now finishing his Ph.D. at Stanford. His dissertation, titled "Making the Manifest Image: Ideas of Agency in Twentieth-Century American Literature," examines ideas of meaningful action configured in the post-analytic philosophy of Davidson, Rorty and others, and the 20th-century American prose of Stein, DeLillo, Bellow and Ellison. He has also published articles on Bellow and on the ethical dimensions of fiction and theory. His next research project concerns the place of moral perfectionism in 20th-century American literature.

MICK GIDLEY is Professor of American Literature at the University of Leeds. He has published several books on American Indian themes and articles on varied literary and cultural topics. His photographic publications include *Kopet: A Documentary Narrative of Chief Joseph's Last Years* (1981), *American Photography* (1983), co-ed. *American Photographs in Europe* (1994) and *Edward S. Curtis and the North American Indian, Incorporated* (1998). He is currently working on studies of Emil Otto Hoppe and Richard Avedon.

PETER HALTER is Professor of American Literature at the University of Lausanne. Among his publications are a study on Katherine Mansfield and the short story as well as a number of essays, ranging from Shakespeare to various aspects of Modernism. His latest book publication is *The Revolution in the Visual Arts and the Poetry of William Carlos Williams* (Cambridge UP, 1994). At present he is at work on a series of articles on literature and photography.

MARTIN HEUSSER holds the Chair for Literatures in English of the 19th and 20th centuries at the University of Zurich. While his long-term research interests are in word & image studies, he has published on numerous subjects from the 17th to the 20th centuries (from Robert Burton to E. E. Cummings) and from repetition in Hardy's novels to the de-Disneyfication of

America. He is currently working on a series of articles on American art and literature with a focus on issues of national and personal identity.

CLARA JUNCKER (Ph.D Tulane 1986) is Associate Professor of American Literature at the University of Southern Denmark, where she has directed the Center for American Studies. She has previously taught at the University of Aarhus, Tulane University, UCLA and the Copenhagen Business School, and was in 1993-94 a Visiting Scholar at UC Santa Barbara. She is past President of the Nordic Association for American Studies. She has published widely on both sides of the Atlantic within the fields of 19th- and 20th-century American Literature, African American Studies, Women's Studies, Southern Studies, Composition and Literary Theory, most recently *Through Random Doors We Wandered: Women Writing the South* (2002).

CHRISTINA LJUNGBERG teaches English literature at the University of Zurich. She is the author of *To Join, to Fit and to Make: The Creative Craft of Margaret Atwood's Fiction* and has co-edited (with Winfried Nöth) a special issue of *Semiotica* on "The Crisis of Representation." She has published several articles on the use of various visual media such as maps and photographs in postmodern and postcolonial fiction. She is currently preparing a collection of essays on the interrelations between verbal and visual media and a book project on maps in fiction.

DEBORAH L. MADSEN holds the Chair of American Literature at the University of Geneva. Her books include *The Postmodernist Allegories of Thomas Pynchon* (1991), *Rereading Allegory: A Narrative Approach to Genre* (1994), *Postmodernism, A Bibliography, 1926-1994* (1995), *Allegory in America: From Puritanism to Postmodernism* (1996), *American Exceptionalism* (1998), *Feminist Theory and Literary Practice* (2000), *Understanding Contemporary Chicana Literature* (2000), *Maxine Hong Kingston* (2001) and *Chinese American Literature* (2002). She edited *Visions of America Since 1492* (1994) and *Beyond the Commonwealth: Expanding the Postcolonial Canon* (1999). Her current research focuses upon exceptionalism, authenticity and the multi-ethnic literatures of the United States.

BEVERLY MAEDER teaches American literature at the University of Lausanne. Among her publications are comparative work on modernist fiction and a number of articles on Wallace Stevens. Her recent research cen-

ters on modernist and contemporary poetry. She is author of *Wallace Stevens' Experimental Poetry: The Lion in the Lute* (St. Martin's, 1999).

MARGUERITE MORITZ is Professor in the School of Journalism and Mass Communication at the University of Colorado at Boulder. She studies issues of media representation, particularly on American television. Her recent work looks at the coverage of high visibility, traumatic stories such as the high school shootings at Columbine. Her documentary, *Covering Columbine*, has been screened widely in the US and her research will be part of the forthcoming book, *Image Ethics in the Digital Age*. She has also written extensively on issues of gays and media. Her doctorate is from Northwestern University.

ROBERT REHDER is the author of *Wordsworth and the Beginnings of Modern Poetry*, *The Poetry of Wallace Stevens*, *The Compromises Will Be Different* (poems), ed. *A Narrative of the Life of Mrs Charlotte Charke* (1755), *The Motive for Metaphor: Stevens, Williams and Crane* (forthcoming), ed. *From Rousseau to Wordsworth*, co-ed. *Imprints and Revisions: The Making of the Literary Text 1759-1818*.

FRANÇOIS SPECQ teaches at the Université Lumière-Lyon 2. He has written a doctoral dissertation on the latter years of Thoreau's Journal and published articles on Thoreau, Melville and Emerson. His translation of Thoreau's *The Maine Woods* is forthcoming from Editions Rue d'Ulm, Paris.

BORIS VEJDOVSKY teaches the literatures of the Americas and American culture at the University of Lausanne. He has published articles on Cotton Mather, Herman Melville, Wallace Stevens, Claude McKay and others, as well as on cultural and critical theory. He is co-editor of a volume titled *Body Politics* (Lausanne, 2001). His current work includes an edition project on multiculturalism considered from a transatlantic perspective, and a book project on representations of death in US culture. The essay contained in the present volume is connected to the latter project.

PATRICK H. VINCENT is assistant-docteur in the Department of English at the University of Fribourg. He received his Ph.D. from the University of California, Davis in 2000. Currently he is writing a book on political representations of Switzerland from 1760 to 1830 and preparing an annotated edition of Helen Maria Williams's *A Tour in Switzerland* (1798). He has

published reviews and articles on women's poetry and the poetess figure, on Wordsworth and on Mary Shelley. His book, *Elegiac Muses: Europe's Romantic Poetess, 1820-1840*, will be published in 2004 by the University Press of New England.
