LUKAS BLEICHENBACHER studied English and French in Zurich, Dublin and Geneva and is an assistant in English Linguistics at the University of Zurich. His research interests include aspects of language choice, language attitudes and multilingual policymaking. A book section on "Language Choice in a Slovak Internet Guestbook" is forthcoming in Language and the Future of Europe (eds. P. Stevenson and C. Mar-Molinero, 2006), and a journal article (in German) on folklinguistic opinions on the choice of foreign languages (English and the national languages) in the Swiss educational system has been accepted for publication in the Bulletin suisse de linguistique appliquée (2006). His main ongoing project is a dissertation about the depiction of individual multilingualism in mainstream Hollywood movies.

ROBIN BLYN is Associate Professor of English at the University of West Florida. She has published a variety of essays on twentieth century literature, film and cultural studies. Recent work appears in Twentieth-Century Literature, South Atlantic Review, and Literature/Film Quarterly. She is currently at work on two book projects, one which studies the relationship between the American avant-garde and spectacle culture, and another which addresses the construction of relativism in the humanities and the social sciences.

MARA CAMBIAGHI is affiliated with the University of Konstanz and teaches in the department of English. She completed her B.A. and M.A. in English and German literature at the University of London (Birkbeck and University College London) and worked as a part-time language-assistant in the Italian department at Royal Holloway New College for three years. Subsequently she returned to Italy to take up a full-time position as a cultural programme specialist and she also completed further studies in English literature at the University of Milan with a dissertation on *Possession*. Her research interests focus on the theory of cultural memory and contemporary fiction. She has contributed several scholarly articles on the fiction of A.S. Byatt in both Italian and English,

as well as reviews and interviews for the electronic publication *Iperstoria*, and the magazines *Diario*, *Linea d'ombra* and *Leggendaria*. She is currently engaged in a project on Mabel Dodge Luhan while continuing research on A.S. Byatt.

ARIF DIRLIK is Knight Professor of History and Anthropology at the University of Oregon. His most recent publications include Marxism in the Chinese Revolution, Global Modernity: Modernity in the Age of Global Capitalism, and an edited volume, Pedagogies of the Global: Knowledge in the Human Interest.

HARTWIG ISERNHAGEN is Emeritus Professor of American Literature at the University of Basel. His publications in American Studies include Asthetische Innovation und Kulturkritik: Das Frühwerk von John Dos Passos, 1916-1938 (1983) and Momaday, Vizenor, Armstrong: Conversations on American Indian Writing (1999), as well as numerous articles on the theory and history of twentieth century fiction (modernism/post-modernism) and the humanities in transition.

DANIELE KLAPPROTH works as a lecturer in English linguistics at the Universities of Basel and Berne. She holds a PhD in English Linguistics from the University of Berne and a Lizentiat (M.A.) degree in English Literature and Linguistics as well as General Linguistics (also University of Berne). In her PhD thesis (completed in 2001), a linguistic-anthropological study of traditional storytelling practices in Anglo-Western and in Central Australian Aboriginal culture, she explored the relationship between narrative practice and cultural identity. She was a Visiting Scholar at Monash University, Melbourne, throughout 1994, and at Melbourne University in 1995, and during that time also carried out intensive fieldwork in Aboriginal communities in Central Australia. Her main teaching and research interests are in sociolinguistics, anthropological linguistics and narratology, focusing in particular on questions of language, power and identity, and on the cultural politics of English in the globalised world.

SUSANNE PICHLER is Assistant Professor at the English Department at the Leopold-Franzens-University in Innsbruck. She published her book on Buchi Emecheta's "London Novels": An Intercultural Approach with WVT in 2001. She has published on Ama Ata Aidoo,

Sam Selvon, Caryl Phillips, and Timothy Mo. Her research interests cover areas like ethnic, intercultural relations, and "Black British" literatures. She is currently working on a project on collective, individual and historical memory in contemporary Caribbean/"Black British" literatures.

MICHAEL C. PRUSSE is Professor of ELT Methodology at Secondary Level I at the Zurich University of Applied Sciences, School of Education (Pädagogische Hochschule Zürich). There he also teaches courses on Literatures in English. His literary research interests range from contemporary British and postcolonial fiction to the genre of the short story and children's literature. He is the author of "Tomorrow is Another Day": The Fictions of James Gordon Farrell (1997). Further publications include articles on Gopal Baratham, Louis de Bernières, J.G. Farrell, Amitav Ghosh, William Golding, Ernest Hemingway, Thomas King, John McGahern, Paul Scott, Graham Swift and Nigel Williams, as well as on the teaching of literature at secondary and tertiary level. His contribution to a volume on Harry Potter and the Philosopher's Stone consists of practical reading tasks for ELT classrooms.

ROGER D. SELL, formerly Professor of English Literature at Gothenburg University, is currently Dean of Humanties and J.O.E. Donner Professor of English Language and Literature at Åbo Akademi University. He has published widely on several different periods of English and American Literature, on the role of literature within language education programmes, and on the implications of linguistic theory for a rehumanization of literary education. Recent publications include Literature as Communication: The Foundations of Mediating Criticism (2000), Mediating Criticism: Literary Education Humanized (2001) and Children's Literature as Communication: The CHILPA Project (2005). He is currently writing a book about Shakespeare and communication, as well as preparing an edition of the complete poems of Sir John Beaumont for the Oxford English Texts series. He holds an OBE for services to English studies, and is an Ordinary Member of the Finnish Society of Sciences and Letters.

PATRICK H. VINCENT is Professor of English and American literature at the University of Neuchâtel. He is the author of *The Romantic Poetess: European Culture, Politics and Gender, 1820-1840* (University Press

England, 2004) and is currently writing a monograph on Switzerland, republicanism and landscape in Romantic-period British literature.
