IOANA BALGRADEAN is an assistant at the English Department of the University of Geneva, where she is writing a PhD. on medieval emotional narratives. She has presented various aspects of her research at conferences at the Universities of Geneva, Lausanne, Berne, and at the Swiss Centre for Affective Sciences, Geneva (SCAS).

ANTOININA BEVAN ZLATAR is a research assistant and lecturer at the English Department of the University of Zurich. She holds a *Diplôme d'Etudes Supérieures* and a Doctorate from the University of Geneva and a BA in English from the University of Oxford. She is currently finalising a book for publication entitled "Reformation Fictions: Polemical Dialogues in Elizabethan England". Her contribution is part of a larger project on Milton's Protestant poetics.

LADINA BEZZOLA LAMBERT has taught English literature at the Universities of Basel, Zurich and Constance. She is the author of *Imagining the Unimaginable: The Poetics of Early Modern Astronomy* (Rodopi, 2002) as well as several essays in the field of sixteenth and seventeenth-century literature. She has co-edited *Shifting the Scene: Shakespeare in European Culture* with Balz Engler (Delaware University Press, 2004) and *Moment to Monument: The Making and Unmaking of Cultural Significance* with Andrea Ochsner (Transcript Verlag, 2008).

REGULA HOHL TRILLINI has been teaching at the English Department of the University of Basel since 2003. Apart from intertextuality and the history of Shakespeare reception, her research interests include literary history, prose fiction from the long nineteenth century, and Word-and-Music-Studies. Her book *The Gaze of the Listener: English Representations of Domestic Music-Making* appeared with Rodopi in 2008. She edits the *HyperHamlet* database (at [www.hyperhamlet.unibas.ch](http://www.hyperhamlet.unibas.ch)).

STEPHEN ORGEL is the J. E. Reynolds Professor in the Humanities at Stanford University. His most recent books are *Imagining Shakespeare*

(Palgrave, 2003), and *The Authentic Shakespeare* (Routledge, 2002). He is the general editor, with A. R. Braunmuller, of the new Pelican Shakespeare.

AD PUTTER is Reader in English Literature at the University of Bristol, and has published widely in the area of medieval literature. His books include *Sir Gawain and the Green Knight and French Arthurian Romance* (Clarendon Press, 1995), *An Introduction to the Gawain Poet* (Longman, 1996), and, with Judith Jefferson and Myra Stokes, *Studies in the Metre of Alliterative Verse* (Medium Aevum Monographs, 2007). He is co-editor (with Elizabeth Archibald) of the forthcoming *Cambridge Companion to the Arthurian Legend*. He is presently completing an edition of the *Gawain* poet's works for Penguin.

KATRIN RUPP holds a PhD. from the University of Berne. She teaches medieval English language and literature at the University of Neuchâtel. Her most recent articles are "Stairway to Hell: Infernal Journeys in Some Old and Middle English Texts" in *Travels and Travelogues*, ed. Jean-François Kosta-Théfaine (AMS Press, 2008) and "The Anxiety of Writing: A Reading of the Old English Journey Charm" in *Oral Tradition* 23 (2008). She is currently writing on the BBC telefilm adaptation of *The Canterbury Tales*.

ERIC STANLEY is Rawlinson and Bosworth Professor Emeritus of Anglo-Saxon at the University of Oxford. He has taught at Birmingham, London, Yale, and Oxford; he is a Fellow of the British Academy, a Corresponding Member of the Bayerische Akademie der Wissenschaften and of the Frisian Academy, and a Corresponding Fellow of the Medieval Academy of America. His publications include an edition of *The Owl and the Nightingale* (Manchester University Press, 1960, repr. 1981), *In the Foreground: "Beowulf"* (D.S. Brewer, 1994), *Imagining the Anglo-Saxon Past* (D.S. Brewer, 2000) and *Die angelsächsische Rechtspflege und wie man sie später aufgefasst hat* (Bayerische Akademie der Wissenschaften, 2000).

DAVID WALLACE is Judith Rodin Professor of English at the University of Pennsylvania. He has recently been Visiting Professor at Princeton and Melbourne Universities. He has made documentaries for BBC Radio 3 on Bede, Margery Kempe, Malory, and Leland. His edited work

includes *The Cambridge History of Medieval English Literature* (Cambridge University Press, 1999, repr. 2002) and, with Carolyn Dinshaw, *The Cambridge Companion to Medieval Women's Writing* (Cambridge University Press, 2003); his books include *Chaucerian Polity: Absolutist Lineages and Associational Forms in England and Italy* (Stanford University Press, 1997, repr. 1999) and *Premodern Places: Calais to Surinam, Chaucer to Aphra Behn* (Blackwell, 2004). He served as President of the New Chaucer Society from 2004 to 2006.

HELEN WILCOX is Professor of English at Bangor University, Wales, where she moved in 2006 after working at the universities of Liverpool (England) and Groningen (The Netherlands). Her research interests concern three main areas of early modern English literature: Shakespeare, devotional poetry, and women's writing. She has published widely in all these fields, including *Women and Literature in Britain, 1500-1700* (Cambridge University Press, 1997) and her definitive edition of *The English Poems of George Herbert* (Cambridge University Press, 2007). She is currently completing the Arden 3 edition of *All's Well That Ends Well* (A&C Black, forthcoming) and writing a book on the year 1611.

LOUISE WILSON is a *maître assistante* at the University of Geneva. She received her BA (Hons) in English Language and Literature from the University of Oxford and MA and PhD in English Renaissance Literature from the University of York. She is the co-editor of *Renaissance Paratexts*, forthcoming with Cambridge University Press.
