Notes on Contributors

BROOK BOLANDER is an assistant for English Linguistics at the University of Basel, Switzerland. Her research interests are in computer-mediated communication (CMC), sociolinguistics and discourse analysis. Within the field of CMC, she is particularly interested in language use and power in blogs, and identity construction/relational work through language in Facebook. At present she is working on a PhD project on the negotiation of power in blogs.

AMIT CHAUDHURI is, according to the *Guardian*, “one of his generation’s best writers.” His latest novel (his fifth), *The Immortals* (London: Picador, 2009), was a *New Yorker* Book of the Year, and Critics’ Choice, Best Books of 2009, in the *Boston Globe* and the *Irish Times*. He is also an internationally acclaimed essayist, and a musician, having performed worldwide as a singer in the Hindustani classical tradition, and as an experimental musician at venues such as the London Jazz Festival and the Brecon Jazz Festival. Among the prizes he has won are the Commonwealth Writers Prize, the Society of Authors’ Encore Award, the *Los Angeles Times* Book Prize, and the Indian Government’s Sahitya Akademi award. He is Professor of Contemporary Literature at the University of East Anglia, and a Fellow of the Royal Society of Literature. He was one of the judges of the Man Booker International Prize 2009. He is also the first Indian writer to have had a *Guardian* editorial written about him, “In Praise of . . . Amit Chaudhuri.”

NIKOLAS COUPLAND is an elected member of the UK Academy of Social Sciences and Research Director of the Centre for Language and Communication Research at Cardiff University. He was founding editor, with Allan Bell, of the *Journal of Sociolinguistics*, published by Blackwell. With Adam Jaworski he edits the Oxford University Press book series, *Oxford Studies in Sociolinguistics*.

MICHAEL DOBSON, Professor of Shakespeare Studies at Birkbeck College, University of London, has worked extensively in universities in Britain and the United States, and has held visiting fellowships in the USA and in China. He comments regularly on Shakespearean perform-

ance and criticism for the *London Review of Books* and the BBC, and has contributed programme notes for the Royal Shakespeare Company, Peter Stein, the Sheffield Crucible, and Shakespeare's Globe. As well as pursuing interests in textual, historical and biographical matters, his work on Shakespeare is particularly concerned with the stage and critical history of the canon from the Renaissance to the present. His publications include *Performing Shakespeare's Tragedies Today: The Actors' Perspective* (Cambridge: Cambridge University Press, 2006), *The Making of the National Poet: Shakespeare, Adaptation and Authorship, 1660-1769* (Oxford: Clarendon Press, 1992), *The Oxford Companion to Shakespeare*, co-edited with Stanley Wells (Oxford: Oxford University Press, 2001), and *England's Elizabeth: An Afterlife in Fame and Fantasy*, with Nicola Watson (Oxford: Oxford University Press, 2002), as well as many articles and book chapters. He is co-editor of the Palgrave Shakespeare Studies monograph series, serves on the editorial boards of *Shakespeare Survey* and *Shakespeare Quarterly*, and is a founder member of the European Shakespeare Research Association. At Birkbeck he is convener of the MA programme in Shakespeare and Contemporary Performance.

ANGELA ESTERHAMMER is Professor of English Literature at the University of Zurich. She works in the areas of English, German, and European Romanticism, performativity and performance, and philosophy of language. Her most recent book publications are *Romanticism and Improvisation 1750-1850* (Cambridge: Cambridge University Press, 2008) and the co-edited volume *Spheres of Action: Speech and Performance in Romantic Culture* (Toronto 2009).

KELLIE GONCALVES received her BA in German and Politics from New York University in 2000. Subsequent to teaching EFL to both children and adults in Voralberg, Austria, she came to the University of Berne and completed her Lizentiat in 2005. She completed her PhD in October 2009 entitled *Language and Identity Performance among Intercultural Couples: An Interactional Approach*. It is a localized qualitative study of Anglophones married to native Swiss German speakers residing in the geographic area of Interlaken. Her research interests include Sociolinguistics, English as a Lingua Franca, Historical Linguistics, Language Change, Discourse and Identity Construction and Narrative Studies. She has taught courses in Historical Linguistics, Macrolinguistics, Discourse and Identity and The History of the English Language.

CÉLINE GUIGNARD is currently a doctoral student and an "assistante diplômée" at the University of Fribourg, Switzerland. She took her master in English and History at the same university and wrote her master

thesis on Ossianic poetry, pseudo-ancient literature of the eighteenth century and Gothic fiction. During the course of her studies, she studied Scottish literature and history, together with Celtic studies, at the University of Edinburgh. Her academic stay in Scotland awakened her interest in Scottish Gaelic and she returns yearly to the Isle of Skye to attend Gaelic classes at the Gaelic College of Sabhal Mòr Ostaig (Colaiste Ghàidhlig na h-Alba). Her doctoral thesis is a study of the representation of Scottish Highlanders, their language, culture and history, in the Scottish literature of the 1890s-1930s. Her interests encompass Scottish and Gaelic literatures, histories and languages, James Macpherson's Ossianic poetry, Gothic, fantasy and horror fictions, and Anglo-Saxon, Welsh and Irish medieval literatures.

MARC HAAS graduated from the University of Lausanne in 2009 (B.A. in Linguistics, English, Film Studies). He is currently doing work towards his MPhil degree in Linguistics at the University of Oxford, which he will complete in 2011.

MIRIAM A. LOCHER is Professor of the Linguistics of English at the University of Basel, Switzerland. Her work has been in the field of linguistic politeness and the exercise of power in oral communication (*Power and Politeness in Action*, Mouton, 2004) and advice-giving in an American Internet advice column (*Advice Online*, Benjamins, 2006). She has edited a collection of papers on impoliteness together with Derek Bousfield (*Impoliteness in Language*, Mouton, 2008), on *Standards and Norms of the English Language* (Mouton, 2008), together with Jürg Strässler, on interpersonal pragmatics with Sage L. Graham (Mouton, 2010) and on computer-mediated communication and politeness (*Journal of Pragmatics*, 2010). She is currently working on illness narratives in a joint project with the medical humanities of the University of Basel.

ADRIAN PABLÉ is Assistant Professor of Linguistics at the School of English, The University of Hong Kong. While his former interests included historical dialectology, sociolinguistics and literary linguistics, he is now publishing in the fields of integrationism and philosophy of mind. He is a member of the editorial board of the journal *Language & Communication*, as well as member of the Executive Committee of the International Association for the Integrational Study of Language and Communication (IAISLC).

BARBARA STRAUMANN is Senior Assistant in the English Seminar at the University of Zurich. Her research interests include literary and cultural theory, psychoanalysis, gender, film and visuality. She is the co-author, with Elisabeth Bronfen, of *Die Diva: Eine Geschichte der Bewunderung* (Munich: Schirmer/Mosel, 2002) and the author of *Figurations of Exile in Hitchcock and Nabokov* (Edinburgh: Edinburgh University Press, 2008) as well as a number of articles on masculinity, celebrity culture, Germaine de Staël, Henry James and Willa Cather. She is currently working on her *Habilitation* project on female performer voices in nineteenth and twentieth-century narrative fiction and another book tracing the cultural afterlife of Queen Elizabeth I.

ALEXA WEIK is an Assistante-docteur in the English Department at the University of Fribourg, Switzerland and currently also an International Fellow at the Rachel Carson Center for Environmental Studies in Munich. She earned her PhD in Literature at the University of California, San Diego in 2008 with a dissertation on cosmopolitan American literature. She has published articles on ethnic and transnational American literature, environmental justice, cosmopolitanism, and eco-cosmopolitanism in the *African American Review*, *The Journal of Commonwealth and Postcolonial Studies*, and elsewhere.
