Notes on Contributors

Laurie Atkinson is an Assistant Professor in the English Department at the University of Tübingen. His research and teaching spans both medieval and early modern English literature, with a particular focus on authorship studies and the history of the book. His first monograph, *Ideas of Authorship in the English and Scottish Dream Vision: Skelton, Dunbar, Hawes, Douglas*, was published with Boydell and Brewer in 2024. He is currently completing a second book project on co-creativity in early English literary print and preparing an edition of Stephen Hawes' *The Pastime of Pleasure* (1509) for publication with the Early English Text Society.

Emma Depledge is professor of early modern English literature at the University of Neuchâtel, Switzerland. She is the author of *Shakespeare's Rise to Cultural Prominence: Politics, Print, Alteration, 1642-1700* (CUP 2018; Pbk 2022). She co-edited *Making Milton: Print, Authorship, Afterlives* (OUP, 2021; with John Garrison and Marissa Nicosia) and *Canonising Shakespeare: Stationers and the Book Trade, 1640-1740* (CUP, 2017; Pbk 2022; with Peter Kirwan). With Rachel Willie, she co-edited a special issue of *Huntington Library Quarterly* entitled *Performance and the Paper Stage, 1640-1700* (2022). She is currently working on a monograph exploring Mock Heroics and the Book Trade.

Elisabeth Dutton is Professor of Medieval English at the University of Fribourg. Her research interests include early theatre, medieval devotional compilations, and writing by and for medieval women. She is the author of *Julian of Norwich: the Influence of Late-Medieval Devotional Compilations* (Cambridge: D.S. Brewer, 2008) and an edition of Julian's Revelation of Love (Yale: University of Yale Press, 2008), and more than thirty-five articles on medieval theatre, and most recently (with Racha Kirakosian) of *Dramatic Wardrobes: The Dynamics of Clothing in Mystical Visions and Religious Plays* (Zurich: Chronos, 2023). She is General Editor of the journal *Medieval English Theatre* and, currently, President of the Société Internationale pour l'étude du Théâtre Médiéval. She is also PI for the SNSF-Project 'WOMARD: Women and Martyrdom in the Religious Drama of the Abrahamic Traditions' (2023-2027).

Ina Habermann is Professor of English Literature at the University of Basel. Her research interests include Shakespeare and early modern drama, literature and film of the interwar period and World War Two, middlebrow writing, the British Mediterranean and Swiss-British relations. She is the author of *Staging Slander and Gender in Early Modern England* (Ashgate 2003), *Myth, Memory and the Middlebrow: Priestley, du Maurier and the Symbolic Form of Englishness* (Palgrave 2010), and *Wartime Cinema, Englishness and Propaganda: Michael Powell and the 'Pressburger Touch'* (Manchester UP 2025). Habermann is the Principal Investigator of the SNSF-Project 'SwissBritNet: Swiss-British Cultural Exchange and Knowledge Networks, 1600-1780' (2023-2027).

Stefanie Heeg is a PhD candidate at the University of Basel, working as part of the SNSF project *SwissBritNet*. Her dissertation focuses on Anglo-Swiss travel accounts in the Early Modern period, and she is recording around 100 Anglo-Swiss journeys in a database. With an interdisciplinary approach that bridges history, literary studies, and digital humanities, she brings a unique perspective to her research. She holds a BA and MA in English literary studies and history from the University of Basel. Her current research interests include critical literary cartography, transcultural exchange, and representations of mountains in travel writing

Honor Jackson is a post-doctoral researcher at the University of Fribourg. Her research interests include Renaissance and Restoration politics, gender politics, utopian thought, travel literature, early modern drama, adaptation studies and book history. In 2023 she successfully defended her PhD thesis entitled 'Gender, Politics and the Utopian Impulse in Late Seventeenth-Century English Literature' at the University of Neuchâtel which she is now working into a monograph. She has published articles in venues such as *Shakespeare Jahrbuch*, *Cahiers Élisabéthains*, *Swiss Papers in English Language and Literature*, and Routledge's *Renaissance World Online*.

Catherine Jenkinson is College Lecturer in History and Julian Schild Junior Research Fellow at Pembroke College, Oxford. In 2024-5, she was also the Research Associate on the Oxford John Fell-funded project *(Hi)stories of Violence: Myth-Making, Imprisonment and the Cultural Identity of the Tower of London* led by Dr Hannah Skoda. The project, a partnership between Oxford, Historic Royal Palaces, and the Royal Armouries, considered the Tower of London's associations with violence across time.

Vivienne Larminie, the British project partner of SwissBritNet, was assistant editor of *The History of Parliament: The House of Commons 1640-1660*, ed. Stephen K. Roberts (2023). Since 2021 she has been honorary general editor of the Huguenot Society of Great Britain and Ireland. Currently also a collaborator in a project to edit the complete surviving memoirs of the regicide exile in Switzerland Edmund Ludlowe, her diverse publications include (editor/contributor) *Huguenot Networks, 1560-1780: the Interactions and Impact of a Protestant Minority in Europe* (2017) and articles addressing links between Swiss, Huguenots and Britons, especially in the area of religion.

David McOmish is assistant professor at the department of philosophy and cultural heritage at the University of Venice, Ca' Foscari. His research focuses upon institutional and literary responses to post-Aristotelian natural philosophy and science in the early modern period.

Andy Reilly is a post-doctoral researcher at the University of Geneva, where he works on the SNSF-funded project, *Shakespeare's Lyric Poetry*, and is also a visiting lecturer at the University of Lausanne. He holds a PhD from the University of Lausanne and is currently preparing his PhD thesis, entitled *William Shakespeare's Hamlet in Publication and Performance, 1709-1735*, for publication as a monograph. His research interests include bibliography and book history, seventeenth- and eighteenth-century drama, and Shakespeare's poetry, and his work has appeared in *Modern Philology* and *Notes and Queries*.

Philippe Bernhard Schmid is a postdoctoral research fellow in the project ‘SwissBritNet: Swiss-British Cultural Exchange and Knowledge Networks, 1600-1780’ at the University of Basel, which is funded by the Swiss National Science Foundation (SNSF). He completed his PhD in modern history at the University of St Andrews in 2022. His research focuses on early modern history, in particular the history of information in the eighteenth century. In 2023, he was a fellow at the *Institute for Advanced Studies in the Humanities* (IASH) at the University of Edinburgh. He held visiting fellowships at Freie Universität Berlin, Harvard University and the Warburg Institute.

Kilian Schindler is assistant professor of early modern English literature at the University of Fribourg. He is the author of a monograph entitled *Religious Dissimulation and Early Modern Drama: The Limits of Toleration*, which was published by Cambridge UP in 2023, and he is co-editor of a recent, trilingual edition (Latin, early modern French and German), of Sebastian Castellio's *On Heretics and Whether They Are To Be Persecuted* (Schwabe 2024), first published in Basel in 1554.

Christiania Whitehead is a Privat-docent and Senior Research Fellow on the Swiss National Science Foundation-funded research project ‘Reconfiguring the Apophatic Tradition in Late Medieval England’ at the University of Lausanne. She specialises in Middle English religious literature. Her recent publications include *The Afterlife of St Cuthbert: Place, Texts and Ascetic Tradition, 690-1500* (Cambridge: CUP, 2020), and, co-edited with Hasel Blair and Denis Renevey, *Late Medieval Devotion to Saints from the North of England: New Directions* (Turnhout: Brepols, 2022).
