SWISS MERCANTILE SOCIETY.

The Swiss Mercantile Society held its Annual General Meeting on Wednesday evening, the 8th inst., at the Club House of the Union Helvetia.

In view of the fact that the members' roll of this thriving association is ra-pidly approaching the highly satisfactory figure of 700, it was somewhat surprising that the percentage of active members present was conspicuously below that proportion which one may reasonexpect to encounter on an occasion ably

of this importance. However, if the Committee's call to its members received rather slight at-tention, they had, on the other hand, the satisfaction that their invitations to supporters and friends of the society had been accorded a better response, quite a considerable number of promi-nent and influential members of our colony honouring the meeting with their presence

Proceedings opened with a dinner, at the conclusion of which the President of the S.M.S., Mr. E. Werner, proposed the toast of "The King" and Mr. Ch. Chappuis that of "Our Native Country." Mr. E. Werner having welcomed the guests of the evening, the Rev. R. Hoffmann-de Visme briefly addressed the gathering, eulogizing the universal im-portance of Commerce and appealing to its representatives as embodied in the S.M.S. steadfastly to pursue their course in good faith and with strong courage, qualities which were particularly needed

The Secretary, Mr. J. L. Veil, read his comprehensive report covering every sphere of the society's activity during the past financial year, details of which we shall give in one of our next issues. after publication of the society's printed report.

The President then moved the adopnem. con., and in the course of his observations on the very satisfactory re-sults of the year under review pointed out that the rapid development and progress of the society are not only heavily overtaxing the capacity of the admini-strative committee, but have also fast outgrown the accommodation which the society has at its disposal for the pur-pose of holding educational classes and other assemblies. It had become an urgent necessity that additional accom-modation should be provided, not for entertaining purposes, which functions usually take place under the hospitable roof of the Union Helvetia, where they felt perfectly comfortable on those occasions, the management catering for them with most admirable care and consideration, but for the classes of the educatio-nal section and possibly for one or two reading and writing rooms and particularly for office accommodation for a per-manent secretary, the creation of which latter post could not be delayed much longer if the interests and further de-velopment of the society are not to suffer. The President therefore proposed that of the available funds a sum of $\pounds 100$ be set aside to provide the nucleus of a fund for securing in the near future such additional accommodation as would be adequate for their growing require-ments. A warm tribute to the manager of the S.M.S. Employment Department, Mr. J. Pfaendler, for his consistent and able conduct of his by no means easy office, and to Mr. F. Eggenberger for his unfailing and successful work in con-nection with the organisation of the edu-cational classes concluded the presidenaddréss. tial

Then rose Mr. H. Martin, First Secreand interesting speech by expressing his pleasure to be present and to be able to congratulate the President and his Committee on the extremely gratifying results of the S.M.S., towards the at-tainment of which their undaunted zeal and devotion had been so instrumental. The speaker also paid a well-merited compliment to Mr. J. Pfaendler, with whom he often had occasion to come into direct contact and for whose qualities he had nothing but praise. Touching upon the serious industrial and commer-cial upheaval both here and in Switzerland, the speaker urged close and earnest co-operation as a contributory means for successfully weathering the present stormy period, and concluded by wishing the S.M.S. continued prosperity and pro-

the S.M.S. continued prosperity and pro-gress. Vigorous applause followed Mr. Martin's speech, which had rivetted the attention of the assembly. After speeches by Messrs. Georges Dimier, A. F. Suter, J. Pfaendler, A. Stauffer, J. C. Rathgeb (the latter being not only one of the oldest members of the S.M.S. but also of the Swiss Colony) and Dr. P. Lang, Mr. Werner announced his retirement as President and that of his retirement as President and that of his Committee, requesting Mr. M.
