On June 17th the Swiss Minister and Madame Paravicini gave a dinner and dance for the whole Staff of the Swiss Legation at the Edward VII Rooms. Hotel Victoria.

A few friends were also asked to the entertainment, which was a very merry and enjoyable evening. M. Paravicini availed himself of this

opportunity to thank his Staff for their readiness in assisting him towards the discharge of his diplomatic duties. M. Charles Corragioni d'Orelli, Coun-sellor of Legation, replied on behalf of

the Staff and expressed to the Minister the deep gratitude of all his "collabora-teurs and collaboratrices" for his great kindness and friendly disposition towards the Staff, and for M. and Mme. Para-

## GODFREY HUNGERBUHLER †

A Charles and the second se

We deeply regret having to record the death of our compatriot, Mr. Godfrey Hungerbühler, who has passed away peacefully on July 10th at his residence, 4, Inverness Place, W.2, after a short illness.

Born at St. Gall in June, 1849, a citizen of the Canton of Thurgau, Mr. Hungerbühler came to London in the year 1877, establishing himself in busi-ness in 1890 as Specialist in Artistic Draperies, Upholsterer and Decorator. in which capacities he succeeded to gain the patronage and great esteem of a wide clientele.

A serious loss is inflicted upon the Swiss Colony, in which the deceased displayed for over forty years a promi-nent and fruitful activity with sincere devotion, true patriotic spirit and pronounced personal modesty.

Since 1879 Mr. Hungerbühler was a member of the Secours Mutuels des Suisses à Londres, without ever having figured on their sick list. He was the designer and organiser of the Embroidered Banner, which was presented to that society by the Ladies of the Swiss Colony, at the celebration of the 200th anniversary of its foundation, at the Hotel Cecil in 1903.

In 1879 our compatriot joined as a member the Helvetia Choral Society, acting as its president during 5 years, eventually becoming Hon. Member of the Union Helvetia in 1900. The "Schweizerbund" he joined in

The "Schweizerbund" he joined in the year 1887, being subsequently also elected Hon. Member and Trustee of this society. On the members' roll of the City Swiss Club Mr. Hungerbühler figured since 1905, and on that of the Nouvelle Société Helvétique since 1916.

Evidence of the master in his own art bore the patriotic decorations arranged xecuted by him on the occasion and executed by him on the occasion of the 600th anniversary celebration of the Swiss Confederation at the "Star and Garter," Richmond, in 1891, and all subsequent big Swiss banquets and fêtes right up to this year's Fête Suisse at King George's Hall, which, unfortunately, was destined to be the occasion of his last appearance at this particular funclast appearance at this particular function, which he had never missed to attend for upwards of forty years. One personal feat of which Mr. Hun-

gerbühler was especially proud was his winning of the 2nd prize in the Veterans' Handicap at the Swiss Sports of 1920 at the venerable age of 71.

The Eglise Suisse and the Fonds de Fonds de Secours pour les Suisses pauivres à Londres also sustain a severe loss, for Mr. Hungerbühler's beneficence was never appealed to in vain.

Nothing we might wish to add to these brief particulars could tend to further emphasize the deplorable fact that the Swiss Colony has lost "One of the Best."

The remains of Mr. Hungerbühler

The remains of Mr. Hungerbühler were laid to rest on Wednesday after-noon at the Kensal Green Cemetery (where the wife had preceded him in 1912), the hearse being covered with over 40 splendid floral tributes. Present at the burial service in the Protestant Chapel were the chief mour-ners: Mr. and Mrs. Emile Hunger-bühler, Mr. John Kupli and Mrs. Bridge; of his personal friends: Mr. and Mrs. Kienast, Mrs. Honegger, Messrs. V. Burkhardt, A. Bodenehr, E. Maeder, E. Fuchs, A. Müller, Walthart, J. Graf and many others. The Eglise Suisse was represented by Mr. E. Boissonnas; the Secours Mutuels by Messrs. G. Forrer, Ch. Chapuis and C. Campart; the City Swiss Club by Mr. Georges Dimier; the Union Helvetia by Mr. A. Wyss; the Schweizerbund by Mr. Theo. Dimier; the Union Helvetia by Mr. A.
