SWISS BANK FOOTBALL CLUB.

SWISS BANK 1st XI v. SOUTH BRITISH INSURANCE COMPANY 1st XI
at Preston Road.

A fairly evenly contested game for the first twenty minutes. Aided by a very strong wind, the visitors made several early raids on the home goal, but were

met by a sound defence. At half-time the Bank led by 2 to 0. The Bank pressed continuously all through the second half and scored eight goals before easing up. All the Bank forwards were on the target: Tobin (4); Gourbache (3); Bohannan, Tobler and Benz all scoring. The home defence proved much too strong for the opposing attack.

The visitors, losing the toss, had to play against a fairly strong wind, and made their game in consequence a defensive one. Steiner, who led the Red's attack, swung the ball about well, and the wings, Rueff and Hildebrand, were clever raiders. After settling down, Smith opened the score for the home team, being the result of a fast run along the touchline by Rueff, who centred in fine style across the goalmouth. In the second half our defence was tested on several occasions, but proved very sturdy. Zur Linden and Peter booting the ball up the field with smart kicks, spoiling every chance of equalising the score. The Swiss, attacking again in turn, succeeded to improve their lead, which point had to be credited to Hickson. It was in the last minute that the Reds' leader broke through—on his own, beating the backs and goalie, and tapping the ball into the net.
