SWISS CHORAL SOCIETY.

The Annual Meeting of this, the youngest of the Swiss Societies in the Colony, took place on Friday, October 27th, at the Union Helvetia, 1, Gerrard Place. Mr. J. Manzoni, the president, opened the meeting at 9.40, and paid a tribute to two members of the Society recently deceased. The Secretary then read the annual report, which testified to the useful activity of the Society. They had contributed to the social part of most of the functions in the Swiss Colony, apart from giving some most successful concerts of their own. The present membership of the Society is composed of 41 active, 25 passive, and 12 honorary members.

Owing to the enforced absence through illness of the Treasurer, the submission of the balance-sheet was postponed to a future meeting. During the re-election of the Committee. Mr. J. Wyss occupied the chair and acquitted himself of this sometimes lengthy proceeding with great ability and in a remarkably short time. Practically the whole of the Committee was re-elected and is now composed of the following gentlemen:—J. Manzoni, President; W. Hausermann, Vice-President; Ernest Moser, Secretary; H. Kronauer, Assist, Secretary; H. Lüscher, Treasurer; J. Haesler, Assist, Treasurer; Jos. Studer, Storekeeper, P. Stoeri, Assist, Storekeeper, G. Berger, Assessor.

The present conductor, Mr. Pestou, having re-

signed, Mr. Manzoni referred to the capable way in which he had brought the choir up to its present satisfactory standard, and the Secretary was instructed to express to Mr. Pestou the thanks and recognition of the members present for his capable work.

As successor the Committee proposed Mr. Walter Meyrovitz, who enjoys a considerable reputation in the world of music, both here and on the Continent, and has proved himself to be a most successful conductor. His appointment was unanimously confirmed.

On reoccupying the presidency, Mr. Manzoni expressed thanks on behalf of himself and Committee for the confidence the members had shewn by reelecting them for another year of office. He pointed out that it would be his endeavour to increase the membership, and in this direction he had been able to come to satisfactory arrangements with the Committees of the two Clubs on whose premises their rehearsals were taking place. Up till now it had been necessary for members of the Swiss Choral Society to be members of either the Schweizerbund or the Union Helvetia in order to gain access to the premises. These two Clubs had waived the enforcement of that particular rule, and any Swiss bent on joining the choir could do so without at the same time joining another Society. The proposal submitted to the president to accept ladies as passive members gave rise to some humorous expressions of opinion, which contributed much to the enjoyment of the evening. After the lengthy discussion a vote was taken, and the innovation was rejected by a large majority. The President, however, declared that he was not discouraged thereby, and that he intended to bring this proposal forward again at a future meeting.

The Society will give a concert at Steinway Hall on the afternoon of December 3rd for the benefit of the Swiss Benevolent Society (Fonds de Secours). The proceedings of the evening were intermingled with songs, thereby creating a very homely atmosphere.
