waltige Fortschritte gemacht, aber die Kunst des Friedenschlusses scheint verloren gegangen zu sein. Der heutige Friede wird nicht bleiben, weil er auf zu unsicherer Grundlage beruht. Der Völkerbund steht gegenwärtig nicht hoch in der Achtung, aber auch er vermag nicht eine Welt, die sich seit Jahrtausenden bekämpft, von einem Tag auf den andern vom Boden des Kampfes auf den Boden des Rechtes zu versetzen. Erst muss der Geist abrücken, dann kann es auch die Armee tun. Mit allen Mitteln wollen wir an der Verbesserung der Gesinnung mitarbeiten, doch — das andere nicht lassen, denn wir müssen die Welt nehmen wie sie ist, nicht wie wir sie gerne hätten.

“So gelangt man neuerdings zu der Frage, wie die Armee in Zukunft aussiehen soll. Das Parlament pflegt die finanzielle Seite in den Vordergrund zu rücken. Da ist zu sagen, dass unsere Militärausgaben von 45 Millionen in der Vorkriegszeit auf 78 Millionen im laufenden Jahre angewachsen sind, was gerade ungefähr der Geldentwertung entspricht. Obwohl die Art der Kriegsführung sich von Grund auf geändert hat, der Umfang des verwendeten Materials in anderen Armeen gewaltig angewachsen ist, sparen wir, sparen wir dermassen, dass den Verantwortlichen der Entscheid über Gestaltung der Ausrüstung und Ausbildung oft recht schwer fällt. Wir suchen mit den gegebenen Mitteln die grösstmögliche Wirkung zu erzielen. Und schliesslich kommt es nicht allein auf das Geld an, sondern auch auf den Geist. Da machen wir stetsfort tröstliche Erfahrungen: bei der Rekrutierung, bei der Dienstleistung, überall herrscht guter Wille. Was ist zu tun, um diesen guten Geist zu erhalten? Keine Frage: der gute Wille herrscht in der Mannschaft, solange sie das Gefühl haben kann, dass ihre Arbeit etwas nützt. Die Armee muss in der Bevölkerung verankert bleiben, dann können wir auch in Zukunft rechnen auf Hingabe und Begeisterung für die Arbeit, die ihren Lohn in sich selbst findet.”

#### LE QUATRIEME COMPTOIR SUISSE.

Alors qu'au deuxième Comptoir suisse, en 1921, les organisateurs avaient eu la satisfaction de voir de nombreuses associations agricoles ou industrielles se réunir à Beaulieu, il est à regretter qu'en 1922, il n'en ait pas été de même. Il semble toutefois que les avantages accordés par les C. F. F. aux visiteurs auraient dû engager des sociétés plus nombreuses à venir officiellement visiter le Comptoir.

Si cela n'a pas été le cas, il faut en chercher les causes dans le fait que les comités des associations, sociétés, fédérations, etc. fixent les date et lieu de leur réunion annuelle au commencement de l'année déjà et que pour beaucoup d'entr'elles il n'est pas possible de convoquer une assemblée extraordinaire à l'occasion du Comptoir.

Il est incontestable cependant que ces réunions professionnelles ont une grande utilité; elles permettent aux participants de se rendre compte, à moins de frais, puisque le Comptoir leur accorde de son côté aussi certains avantages pécuniaires, des progrès réalisés dans la branche qui les intéressent, comme elles donnent aux exposants une occasion unique d'atteindre des visiteurs véritablement acheteurs.

C'est pourquoi la Direction du Comptoir fait ici un pressant appel aux associations industrielles ou agricoles et les prie de prendre note que le 4me Comptoir Suisse est doré et déjà fixé à septembre 1923.

La Chancellerie du Comptoir donnera aux comités tous renseignements, par retour du courrier.

Whilst confessedly wishful to follow literally the advice of “Fair Play” in his letter to *The Swiss Observer*, I suggest that all intending correspondents should make an individual resolve to furnish suggestive information in the most condensed and lucid manner possible.

#### FINANCIAL AND COMMERCIAL NEWS FROM SWITZERLAND.

The directors of the Crédit Suisse met on the 27th of January and passed the accounts for the year 1922, which close with a net profit of Frs. 9,570,160 available for distribution, as compared with Frs. 9,554,429 in the preceding year. The general meeting is to be held on the 3rd of March, and it will then be proposed to pay a dividend of 8 per cent. and thus repeat the distribution of last year. Frs. 1,307,846 will be carried forward, as compared with Frs. 1,291,240 in 1921.

This is the first of the big Swiss banks to publish its preliminary figures. The next few weeks should see similar returns from the remaining concerns, and their publication will be awaited with great interest.

The long drawn out crisis under which the Swiss chocolate manufacturers have been labouring has been severely felt by the well-known chocolate firm of Peter, Cailler, Kohler in Le Tour-de-Peilz, and reports are current in reliable circles to the effect that there will be no dividend on the ordinary shares for 1922. For a number of years previously this firm has been able to pay 10%.

Payment of a liquidating dividend to shareholders of the Banque Commerciale de Fribourg is shortly to be made, and a circular has been addressed to creditors asking whether they prefer to receive the full amount of their claims in 2% 15-year debentures of the Cantonal Bank, or whether they wish to be paid 20 per cent. in cash and 50 per cent. in 5% debentures of either three, five or eight years' duration.

In the present time of industrial depression it is good to hear of the speedy reopening of the glass works at Muenster, which have been lying idle for more than five years. A new syndicate has been formed with extensive connections, extending as far as America. A newly perfected system has been installed, and glass can now be produced by mechanical means and need not be blown, as hitherto. The immediate value of this innovation will be realised when it is recalled that under the old system expert glass blowers had to be brought in from abroad, whereas now Swiss workpeople can be employed and the unemployment position relieved.

In connection with the issue of 8% cumulative preference shares of the Lima Light, Power and Tramways Co. which is being made in Switzerland, it is interesting to learn that the necessary electrical material for the improvement and modernisation of the power stations and railway constructions in Lima is being supplied by the well-known Swiss engineering firm of Brown, Boveri & Co. of Baden. It is also believed that Swiss manufacturers will be given a preference as far as possible.
