## LA NOUVELLE SOCIÉTÉ HELVÉTIQUE.

(Communicated.)

### ANNUAL GENERAL MEETING.

The seventh Annual General Meeting of the London Group of the Nouvelle Société Helvétique took place on Friday, February 16th, in the large hall of the "Schweizerbund." Between fifty and sixty members were present.

After the minutes of the previous Annual General Meeting had been read by the Hon. Secretary, Mr. C. Campart, Mr. Jean Baer, President, read his very substantial Annual Report, which will be published "in extenso" in the next issue of "The Swiss Observer."

Mr. A. F. Suter, the energetic Treasurer, gave, in the circumstances, a very satisfactory report, which proved that the financial crisis with which the Group had been confronted in autumn had been successfully overcome, donations from Switzerland having reached us to the extent of £308. With the active help of the bulk of the members we shall thus be able to enter the new year, knowing exactly how we stand, and being able to maintain the work of the Secretariat in its essence, the Secretary being there three days a week, and the Assistant Secretary attending to the work every day, as hitherto. With the assistance of those members who have returned our ballot paper we may be able not only to defray our expenses, but even to finish 1923 with a small balance in hand.

The auditors' report was heard, and a vote of thanks to Mr. Suter was heartily responded to by the meeting.

Mr. Schupbach was elected chairman during the election of the new Council and read out as such the general programme for 1923, which did not raise any discussion.

The proposal of the Council to raise the subscription to 10s., which was based on the result of the ballot papers, the great majority of those returning it having voted for 10s., was agreed to after a short discussion.

Mr. Gelingier thanked the outgoing Committee and the Acting Secretary for the great work they had carried on throughout the year. A vote of thanks to the Committee was then heartily given by the meeting.

Mr. Weber and Mr. Zimmermann were again elected auditors, and the following members were elected as Councillors for 1923:—J. Baer, F. Beyli, P. F. Boehringer, C. Campart, Dr. A. Daeniker, Rev. Hoffmann-de Visme, H. Joss, C. Kiefer, T. Schaerer, A. Schmid, J. Strahlé, A. F. Suter, Dr. W. Wegelin, Dr. W. Weibel.

### MEETING OF THE COUNCIL

on February 21st.

The first meeting of the new Council was attended by about twenty Councillors.

1. Mr. Ritter spoke a few words of thanks to the Committee, and especially to the Chairman, when they retired for re-election. Messrs. Baer, Beyli, Campart, Suter and Dr. Weibel were all unanimously re-elected as members of the Committee for 1923.

2. The following Sub-Committees were elected for 1923 (the majority of these members have already consented to serve):—

Art Commission: F. Beyli, Dr. Paravicini, T. Ritter, T. Schaerer, Dr. W. Weibel, G. Wüthrich.

Budget Commission: H. Joss, A. F. Suter, J. Weber.

Entertainment Committee: J. Pfander, Dr. A. Daeniker, C. Campart, C. Bertschinger, Dr. A. Daeniker, J. Hausermann, J. Pfander, A. Renou.

H. Roost, Rev. U. Wildbolz.

Financial Committee: A. F. Suter, P. Walsler.

Press Committee: Dr. Bodmer, J. H. Buchi, Dr. Daeniker, Miss Reutiner, Dr. Wegelin, Dr. W. Weibel, Dr. E. Zehnder.

Propaganda Committee: J. H. Buchi, Dr. A. Daeniker, T. Weber, Dr. Wegelin, F. Zimmermann.

Delegates Swiss Sports Committee: E. Bloch, F. Golay.

A proposal was adopted to the effect that, as a general rule, those commissions should have the power to co-opt other members in the course of the year, if they thought it necessary, and on condition that all are members of the Group.

3. The President summarised circulars of the Secrétariat des Suisses à l'Etranger, No. 36 (Zones), 37 (emigration) and 38 (pavilion of the Fourth Switzerland at the Basle Samples Fair). The programme of the Auslandschweizertag, which had just been received, was also read. Further details were given as to the enquiry of the Männerchor, Zurich, which is studying the question of a visit to London, coupled with a concert, in 1925. The Secretary will collect information from different quarters. He has also approached the Legation in this matter. The Committee was asked to make the necessary arrangements for the publication of the presidential annual report in "The Swiss Observer." It was agreed that we should have, besides the dinner, in May also a lecture by Director Tobler of the Landerziehungsheim Hof-Oberkirch.

4. The Treasurer reported favourably on the financial situation and presented five resignations. It was decided that those members who had not paid their subscriptions for 1920-21, in spite of reiterated demands, should now be taken off our lists. We will thus be the poorer by about fifty members.

5. A report of the Swiss Sub-Committee to the League of Nations Union and one of the Entr'Aide Committee were read.

6. The Secretary made a few communications with regard to his activity: (a) The Helvetic Bibliography will be published in the forthcoming issue of the "Swiss Travel Almanac," and 5,000 separate copies of the Bibliography will be put at our disposal by the Swiss Tourist Office. The London Group thus saving only to defray the postage, these 5,000 copies will be

sent out as soon as they reach London; (b) A note about the services offered by the Secrétariat was published in the last Bulletin of the National Union of British Students, which reaches 50,000 affiliated students; (c) An information leaflet for Swiss students in London has been edited by the Secrétariat and will be distributed to those who apply for it; (d) A circular will be sent out shortly to all the Swiss universities, asking them to draw the attention of Swiss students to the educational opportunities of the University of London; (e) An article about the abuse of the Swiss Emblem was published in "The Swiss Observer." (f) An energetic campaign, in order to interest English publishers in translations of modern Swiss fiction, will be undertaken within the next fortnight.

7. The offer of the "Foyer Suisse," concerning new rooms for the Secrétariat and for Council meetings, was rejected after a long discussion and after a report of a special commission of three, which had visited the premises, had been heard.

8. The draft of the new law about the military tax was discussed in connection with a legal report which we had received, through the offices of the Secrétariat des Suisses à l'Etranger, on the practice of enforcing the military tax. This report also contained a new suggestion, viz., to give Consuls the power to assess the Swiss abroad, instead of the cantonal authorities. The matter not coming up for debate in the Chambers in the immediate future, it was decided to postpone the discussion until the next Council meeting, so that members may prepare themselves more fully for it before adopting a resolution.

9. With regard to the Matriculation Card, the following resolution was adopted:—"The Council of the London Group of the N.S.H., in view of the present practice of matriculating Swiss abroad having proved a failure, mostly on account of the fee having been found too high, resolves that the S.S.E. be urged to use all its influence, through the medium of the Parliamentary Group and otherwise, in order that the fee for the Matriculation Card Swiss abroad, for the first time as also for renewals, be fixed at the nominal sum of about fr. 1.25 per head of family, and that this be stipulated in the new Consular Regulations which are being prepared by the Federal Council." This resolution will be sent to the S.S.E. and the Swiss Minister.

Mr. Th. Schaerer, rappelle l'anniversaire de notre Trésorier, Mr. G. Dimier, et propose de lui adresser un télégramme de félicitations. Cette proposition est reçue aux acclamations de tous, ainsi que celle de Mr. E. Fuchs, de marquer ce souvenir par une collecte en faveur du Fonds de Secours, qui produit la somme de deux guinées.

L'organisation de notre Banquet annuel est ensuite l'objet d'une longue discussion à laquelle la majorité des membres présents prennent part.

Les deux résolutions suivantes sont adoptées: De remettre à l'Assemblée Générale la discussion et s'il y lieu la nomination d'une Commission spéciale d'organisation, de charger le Comité du Club, de s'assurer une option pour le dernier Vendredi de Novembre sur les Salles du Prince's Restaurant, du Cecil Hotel, de l'Hotel Victoria et d'autres si possible et d'inscrire à nouveau cette question à l'ordre du jour de notre Séance de Mars.
