MEETING OF THE COUNCIL on March 21st, 1923.

The Swiss Minister has kindly consented to take the Chair at the forthcoming lecture by Prof. Zschokke on "The Swiss National Park" in King George's Hall.

2. Two members were admitted, and there were vo resignations. The total number of members two resignations. is now 426.

3. Mr. Theo. Schaerer was appointed delegate to the Day for Swiss Abroad of the Basle Samples' Fair. Some recent information about the programme for that day was given.

4. On June 1st we shall have a lecture in Ger-man on "Die Landerzichungsheime" by Director Tobler at 28, Red Lion Square, and on October 19th one in French by Dr. Paul Lang on "La Littérature contemporaraine de la Suisse romande." 5. A letter from the Hon. Assistant Secretary of the Swiss Sports Committee was received, asking us to broadcast the desire of this Committee to

have as many societies participating in the teams as possible this year. The invitations will be sent out for the Swiss Sports together with those for the lume leature the June lecture.

out for the Swiss Sports together with those for the June lecture. 6. The Secretary made a few communications with regard to his activity: -(a) $\overline{\Lambda}$ circular letter was read and will be sent to prominent English publishers, with a view to interesting them in con-temporary Swiss fiction. The circular will be ac-companied by a list, containing information on about 30 of the best books of Swiss fiction which have appeared since 1900; (b) The Groups of Bradford, Manchester and the Schweizerklub of Liverpool will be offered lectures by the Secretary for April 25th to April 29th; (c) An article was sent to the "Yorkshire Post;" rectifying a state-ment *re* compulsory domestic service in Switzerland and one on the National Park to "The Swiss Observer"; (d) The Secretary is helping the Na-tional Union of Students of Evgland and that of Switzerland with regard to the organisation of the exchange of students in summer. He is also gather-ing some new information for the Swiss Central Office for University Information, which is about to prepare a booklet on Swis university conditions for the use of English students. He will give every possible help to members of the staff of the Swiss Federal Railways who will come to England with a view to improving their knowledge of the language. with a view to improving their knowledge of the language.

7. Two members were elected to the Entertainment Committee. It was decided that the dinner will be definitely arranged for May 18th.

8. The President read a causerie by President 8. The President read a causerie by President Vogel, of the Florence Group, on the question of the Military Tax Bill and the Resolution adopted by this Group. The members of the Council, having received a copy of this Bill beforehand, an exhaustive debate took place. All the different aspects of the Bill were carefully studied. Finally the meeting voted on a general principle and four specific claims, which should be embodied in a Resolution. A committee of three was elected which will draft a Resolution and submit it to the Council at its next meeting for ratification. Council at its next meeting for ratification. 
with Swiss gatherings, all joined in a number of Swiss choruses. All present left with thanks to the Chef de Cours, who organised the very pleasant function. A. L.
