A person who acquires at his birth Swiss as well as British nationality may at any time, after having attained majority, renounce either of his two nationalities. Should he give up his British nationality, he remains, as he was already before, a "fully qualified" Swiss citizen. It is obvious that in this case the Articles quoted above do no longer analy. longer apply.

As regards military duties, it must be pointed out that a Swiss citizen who, by reason of his possessing also the nationality of another country, has been enrolled in its army is, according to a decicient of the state of the s possessing also the nationality of another country, has been enrolled in its army is, according to a decision of the Federal Council, free from military service in Switzerland, but has to pay the Swiss military tax. He is, however, exempt from payment of this tax for the years in which he fulfils his Foreign military obligations, provided that they are compulsory and that he is at the time domiciled in the country in question.

### NOUVELLE SOCIETE HELVETIQUE.

Meeting of the Council on Wednesday, June 18th, at 28, Red Lion Square, W.C.1.

- The Treasurer announced one admission and resignations. The total membership is now nine resignations. 333.
- 2. After some discussion it was decided not to change the usual hour of the Council Meetings, which will in future always be held at 7.30 p.m.
- 3. The Secretariat received a letter from Mr. H. Bosshardt, President of the "Département des affaires étrangères de la Fédération Suisse des Etudiants," informing it that 36 Swiss students will come to London at the end of July, the journey being organised by the National Union of Students of England and Wales. In his letter Mr. Bosshardt emphasises the desire of these students to get into touch with the Swiss Colony in London, as they had done when visiting towns in other as they had done when visiting towns in other countries; Mr. Baer suggested that this letter should be transmitted to the special Committee which is arranging the First of August Fête. This suggestion was unanimously agreed to.
- 4. A general discussion arose in connection with the question of the Swiss children in London and the advisability of taking action in the Swiss Colony to prevent their denaturalisation. The following gentlemen were amongst those who spoke on this matter: Messrs. Bachofer, Baer, Campart, Emmenegger, Ritter, Suter, and so on. One of the suggestions which was much appreciated was to study the possibility of forming a 'Familienheim' in Switzerland to which the children of the Swiss Colony could go during their holidays. The result of a discussion, which took place by members of the N.S.H. several years ago as to the possibility of founding a Swiss School in London, was also recalled, and everybody agreed it would not be feasible. As to the Secretary's suggestion to try to arouse interest in this matter amongst the London Swiss by means of organising special meetings for children, many members appeared sceptic about the success of such an undertaking on account of 4. But they were quite agreeable to allow the Secretary to see if it would be possible to convoke a special meeting at which as many members of the Swiss Colony as possible would have an opportunity of expressing their views.

  5. The Secretary raised the question of free transfer of members of the N.S.H. from one Group to another. As a matter of fact, there are sometimes Swiss who come to London only for a short time and who would like to participate in the life of the Society, but not without a guarantee that they will be able to transfer to another Group when they return to Switzerland without having to pay a new subscription. Several members of the Council emphasised the practical difficulty of such an arrangement, but all were agreed that something should be done in this connection, and they asked the Secretary to write to the S.S.E. at Fribourg, requesting them to study the question.
