FINANCIAL AND COMMERCIAL NEWS FROM SWITZERLAND

Reviewing general economic progress in the year 1924, the Directors of the Swiss National Bank in their annual report admit that the year presented a more satisfactory picture than did those which preceded it. For the first time since the end of the war it was possible to record in every country a desire to surmount difficulties by way of mutual accord. The encouraging results of the League of Nations' efforts at reconstruction in Austria had their sequel during 1924 in a similar action in regard to Hungary, and the elaboration and final adoption of the Dawes Plan in a large measure reduced the greatest obstacle to the reestablishment of a normal state of affairs in Europe by removing the uncertainty which had reigned on the subject of reparations. America's readiness to co-operate in the restoration of Europe is greeted as a hopeful sign. The directors add that as a Bank of Issue they cannot remain silent with regard to the great part played by the Bank of England in this work of reconstruction. The Bank has, from the outset, placed all its influence and all has, from the outset, placed all its influence and all its great power at the service of these efforts at

A better atmosphere has also reigned in regard A better atmosphere has also reigned in regard to monetary questions. Though there is still a long way to be traversed before a general state of monetary stability is reached, great progress has been registered through the general return to the principle of the gold standard. All the reconstruction schemes which have been carried into effect are in reality founded on the principle of the gold standard.

In Switzerland a revival of business activity may be mentioned in the domain of the watchmaking industry, the building trade, the hotel-keeping industry, and transport. The formation of new capital has not yet regained its normal level, even in those trades which were fairly well occupied, since owing to the high cost of living in Switzerland, numerous industries, especially those working for export, have been obliged to sell their goods at prices which leave them hardly any profit, in order to allow them to maintain their degree of activity at all.

The Société Suisse pour Valeurs de Métaux in Basle closed the year 1924-25 with a net profit of Frs. 1,951,289, as compared with Frs. 1,711,572 in the preceding year. The dividend proposed is $7\frac{1}{2}9_0$, as compared with $6\frac{1}{2}\%$ last year.

The Swiss engineering firms which have been successful in obtaining a contract in connection with the Sukkur dam are now announced to be the Schweizerische Lokomotiv- und Maschinenfabrik in Winterthur and the Maschinenfabrik Oerlikon. The order is for two 750-h.p. Diesel engines from the Winterthur company, in direct conjunction with alternators of the Oerlikon make.

1. The Treasurer and no admissions to announce this month, but there were one or two resignations to be intimated, and several of our communications had been returned owing to members having changed their addresses without notifying us. It is hoped that we shall be able to obtain the new addresses of some of those.

2. The President brought the following to the notice of the meeting:—(a) The Union Helvetia had applied to us for a lecturer either with regard to the catering business or some subject of national interest. As the latter is more in the line of the N.S.H., we shall endeavour to do what we can of find somebody suitable to address the Union Helvetia on a national subject, and steps are already being taken to this end. (b) A letter has been received from our representative in Switzerland, Mr. G. Gerber, stating that he would no longer be able to act in this capacity. (c) Monsieur Ch. Paravicini, the Swiss Minister, has very kindly consented to take the chair at the Charity Concert which we are arranging in aid of the Swiss Benevolent Society on

3. It was unanimously decided that the President's Annual Report should again be published in The Swiss Observer, and that sufficient copies should be obtained to send one to each member, and have a certain number over for propaganda

purposes.

4. For some time past we have been endeavouring to fix a convenient date for the reading of a most interesting lecture by Mons. Ed. Recordon on "La N.S.H. et le problème de l'éducation nationale" which we received some months ago from the S.S.E. There have always been so many other lectures and events in the London Swiss Colony that it has not been possible to read this address up till now, but after some discussion by the Councillors and consultation as to futurer events in the Colony, it was decided that Friday, May 15th, would be a suitable date, and notification of this will be sent at once to The Swiss Observer.

5. Letters were read from Mr. M. Bachofer and Mr. G. H. Weber. Mr. Bachofer expressed his regret at having to resign from the Committee owing to his having so frequently to be absent from town, but he signified his desire still to serve on the Council. Mr. Weber also felt he ought not to remain a member of the Committee, owing to his inability to attend many of the meetings on account of his being unable to get away in time for them.

6. The President then tendered the resignation of the Committee to the Council, but the meeting immediately and unanimously elected Mr. Baer (President), Mr. C. Campart (Hon. Secretary) and Mr. A. F. Suter (Treasurer) to their respective offices again. Mr. G. H. Weber was also asked if he would not re-consider his decision, the Council being persuaded of the help he rendered the Society by serving on the Committee, and, after some hesitation, he very kindly agreed to accept relection, much to the satisfaction of the meeting. In the place of Mr. Bachofer, whose inability to serve on the Committee again was much regretted, Mr. E. Neuschwander was unanimously elected.

7. Mr. Ritter then rose to offer a vote of thanks to the Committee for the splendid work they had done throughout the year. All those who had ever served on the Committee knew what a great deal of work that meant, and Mr. Baer in particular, he said

their untiring support.

Sir,—I noticed with a great deal of misgivings that there were last Saturday no less than four important events in the Swiss Colony, viz., City Swiss Club Cinderella; Concert of the Swiss Choral Society: Constitutional Meeting of the Swiss Gymnastic Societies; Social Entertainment at Swiss House. It must have been a very difficult choice for my compatriots as to where to attend, and it is easy to imagine that every one of these functions must have suffered by the simultaneous occurrence of the other three.

May I be permitted to remind the various Societies of the Colony of the proposition recently brought forward by the N.S.II. The intention of the N.S.II. is to save time and expenses, to study the convenience of the Colony, and to prevent overlapping or simultaneous occurrence of such functions by their scheme of keeping the Societies advised of forthcoming events. This can only be done if the Secretariat is fully kept up to date by the various Societies as to their functions. Last Saturday is a case in point and in proof of the usefulness of such co-ordination.

I therefore appeal to the Colony to give this system a chance. Naturally some functions held in the Colony are more difficult to arrange than others, especially where big halls have to be booked far in advance, but I feel convinced that the Secretariat is capable of preventing such serious overlapping as happened last Saturday, and is in the position to arrange such occasions to the satisfaction of all Societies and to the greater benefit of the Colony at large.
