. The last Monthly Meeting of the London Group of the N.S.H. until after the holidays took place on Wednesday, June 16th, at the Secretariat, 28, Red Lion Square.

The Treasurer's report was satisfactory, and he

had neither admissions nor resignations to report this month.

The Tresident read letters from the Swiss Institute, the Swiss Mercantile Society, and the Swiss Y.M.C.A. which he had received in reply to our circular, suggesting a lecture by Dr. H. Egli next autumn on the subject of the Revision of the Federal Legislation on Alcohol. All these societies have kindly agreed to give us their support in this connection. It was agreed that Dr. Egli's lecture should be held on October 29th in the Ashburton Hall, 28, Red Lion Square.

The President then read Circulars 64 and 65 which we had received from the Secretariat of the Swiss Abroad, and also brought the official invitation to the "Day for the Swiss Abroad" (15th September) to the notice of the meeting. This invitation has been circulated amongst all the Swiss Societies in London, and we have also done our utmost in other ways to endeavour to organise a party to go to Lausanne for the "Day but, unfortunately, without any success so far.

Other communications brought to the notice of the Council were a letter from Monsieur R. Hoffmann, President of the Commission des Suisses à l'étranger, and a circular from the Swiss Rifle Association. Monsieur Hoffmann expressed his appreciation of the fact that we are studying the question of the Revision of the Federal Legislation on Alcohol, and hoped we would also discuss the Monopoly on Corn. The view was expressed that the latter had not the same national importance as the former, but that it might, nevertheless, be a good thing to get some material on the subject from the S.S.E. good thing to get some material on the subject from the S.S.E.

The circular from the Swiss Rifle Association asked us to appoint two delegates to take part at a meeting of representatives of all the other London Swiss Societies for the purpose of discussing the proposal to celebrate the National Fête by an "Open-Air Meeting" of patriotic and partly religious character on Sunday, August 1st. WILLIAM RAPPARD †

We regret to announce the death of Mr. We regret to amount the deam of the William Rappard, who passed away, after a prolonged illness, at the age of 78, last Friday, the 18th inst., at his residence, "The Orchard," The Mount, Sydenham, S.E.26. He was buried last Wednesday

S.E.26. He was buried last Wednesday in the family grave in Norwood Cemetery; in addition to the members of the family and intimate friends, there were present Monsieur Paravicini, the Swiss Minister, and Mr. M. Gerig, the secretary of the City Swiss Club.

The late Mr. W. Rappard, who received his early education in Berne, commenced business life in a Bank in Basle in 1871, but he soon afterwards came to London, where, in 1885, he took over the firm of C. Hoffmann & Co., ship and insurance brokers, which business he carried on successfully in times both good and bad until his death.

He became a member of the Baltic Shipping Exchange in 1893, and at the

He became a member of the Baltic Shipping Exchange in 1893, and at the time of his death he was one of the oldest, if not the oldest, shipbrokers in London. Before the war he was the Lon-don broker for all Russian, German and Dutch sailing vessels, and was an autho-rity on the Portuguese, North African, West Indian and South American trades, and since the war he has interested himself in the newly-formed Republics of Latvia in the newly-formed Republics of Latvia and Esthonia, where he had many business friends who esteemed his friendship and

He was not one to go very much into society outside his own intimate circle, but he was a member of the Swiss Alpine Club, and he had been a member of the City Swiss Club since 1875 and was elected an honorary member of the latter club in

The last few years of his life were unfortunately overshadowed by family be-reavements, he having lost his wife, three daughters and a brother almost within a decade, but he bore it all with a firmness that was characteristic of him all through his life. He had a large number of old friends in Basle, most of whom, however, have passed away during the last few years, and although the greater part of his life was spent in London, he was very fond of his native Switzerland, particularly of the Bernese Oberland and the Engadine, where he invariably spent a few weeks out of the year. It is common knowledge, but nevertheless well worth mentioning, that Professor Rappard, of Geneva, who has been very active in connection with the League of Nations and who was a personal friend of the late President Wilson, is a nephew of the late Mr. W. Rappard.

Such men as Mr. W. Rappard are not met with every day, and when they pass away, leaving only memories, their place cannot be filled, but those who were intimately connected with him can only feel relief that, after a long life devoted to work, but marred in the end by loss of family and personal suffering, he is at last at rest.
