He then read a letter which had been received from one of the Councillors with regard to a communication which we had received from Monsieur R. Hoffmann in connection with the "Day for the Swiss Abroad," which will have quite a new character this year, and will be held at Lausanne on September 15th. The Councillor in question had also made one or two suggestions as to possible activities of the London Group in his letter, and it was hoped that he might now give the Meeting the benefit of these in a more definite form. In response to this the gentleman in question gave an interesting statement as to how the London Group might in future evolve its activities. As examples of points with which the Group might busy itself he quoted the difficulties made by the Eidg. Arbeitsamt for Swiss Abroad to obtain posts in Switzerland should they wish to do so, and also the unfair treatment often meted out to Swiss in regard to passports who were behindhand with their Military Tax. It was his opinion that, if the N.S.H. took these matters up energetically, something might be done to improve them. The N.S.H. was certainly the only Society in whose province it lay to take such steps.

A lengthy discussion followed these remarks, only Societ

A lengthy discussion followed these remarks, and it was ultimately agreed by the Meeting that the Committee should go into the question of the Military Tax again with a view to seeing what might be done in the matter. It was further decided that, in view of the wish expressed by one of the members at the Annual General Meeting, and as to do so would entail no alteration in our Statutes, we should henceforth announce our monthly meetings as "Monthly Meeting of the Group," instead of Monthly Council Meeting.
