The Secretary, in presenting the Financial Report (as per extracts hereunder) expressed regret that the General Fund shows a loss for the period under review, caused through heavy expenses and other adverse circumstances. He was, however, very glad to acquaint the Meeting that the scholastic activities embarked upon by the London Section of the Union Helvetic have proved very successful hitherto and the gratifying results attained strongly suggest a continuation of the function of their School for Hotel employees.

The Accounts presented were duly accepted, with thanks, and the customary *décharge* was accorded to the outgoing Administration.

M. Finger, as Manager of the Employment Registry, thereafter submitted the report of his office and gave the following figures of results secured :

OFFICE REPORT.

Register Fees received from 1922 to April, 1928 :— £282 17s. 11d. for 1922 ; £352 19s. 9d. for 1923 ; £303 1s. 10d. for 1924 ; £322 7s. 10d. for 1925 ; £253 9s. 4d. for 1926 ; £264 9s. 7d. for 1927 ; £83 2s. 6d. up to April, 1928.

He (M. Finger) pointed out that the change in the management of his office naturally had disturbed results somewhat, but good headway was now being made and he had full confidence in predicting better results in the near future.

A complaint having been levelled against M. Finger in connection with a specified case of "placement," the Meeting decided to have the matter gone into forthwith and MM. Borgeaud, Indermauer, Jaquenoud and Sermier were nominated to investigate the features and merits of such complaint. After due deliberation these delegates returned and expressed satisfaction at being able to record their verdict in favour of M. Finger, who was thereupon heartily thanked for his services, and the report relating to the Employment Registry unanimously accepted.

M. Martig expressed appreciative thanks for the hard work performed by the Administration during its tenure of office.

The revision of the Rules for the British sections of the Society thereupon claimed the earnest and protracted attention of the Delegates. The Administration having proposed that a lévy be made on the members as a whole as and when the death of one of its number occurs, in order to pay to the relatives of such deceased member a fixed sum towards burial expenses, etc., the Delegates were at first not much in favour of such a proposition, but ultimately it was decided to make a levy of 2/- for the first year and 1/- for the subsequent year.

M. Lehrian proposed the creation of a Voluntary Benevolent Fund, for which the sum of £50 is already available, and it was decided to draw up special rules governing the operations of this new Fund.

The Administration also proposed to introduce a certain charge to Members for services rendered by the Employment Registry, in the event of their being "placed," with a view to improving the impaired state of the General Fund and to accumulate some funds wherewith to propagate the activities of the Registry Office. After lengthy discussion this proposition also found acceptance.

The drafting of special Rules applicable to "Branche Culinaire" was also decided upon; it being agreed that in order to ensure closer and more cordial relations between the various professional interests of the Society's members, the President of "la Société culinaire Suisse" as a daughter society of the London Union Helvetic, shall henceforth automatically become a member of the "Administration territoriale."

The Agenda of the meeting having now come to an end Mr. Borgeaud tendered the resignation of the administration. He reiterated at some length the difficulties against which they had to fight, difficulties which he was prepared to face again if re-elected, though he would give every assistance in his power to a new Committee. A lengthy discussion preceded three separate ballots, from which finally Mr. Indermauer emerged as the new President of the Territorial Administration for the ensuing five years. Mr. Indermauer, in taking the chair, expressed thanks for the great confidence placed in him and his colleagues. He also paid tribute to the excellent work done by the outgoing Committee, whose president, M. Borgeaud, was elected Honorary President. A vote of thanks

was also passed to M. Martig and the other members of the "Comité du Jour," whose untiring efforts had so much assisted the successful conduct of the meeting.

On the proposal of Mr. Indermauer it was unanimously decided that all past presidents of the Administration and other Committees should form an Arbitration Board to which all difficulties should be submitted for their advice. It was further decided that managers and hotel proprietors should become eligible as Club members without the existing qualification of being acting members of the Society.

The meeting closed at 10 p.m.

All the delegates were entertained for lunch by the Club Commission, and in the evening were the guests of the administration.
