ANNUAL GENERAL MEETING,

Swiss House, Feb. 27th, 1929.

The Annual General Meeting of the Swiss Mercantile Society was preceded by the monthly Supper, and it was amongst a large gathering of Members that at 8 p.m. our President, Mr. A. C. Staehelin, opened the proceedings.

He offered, on behalf of the Society, a hearty welcome to our guests, Messrs. W. Obrist, Manager of the Union de Banques Suisses, Baden; H. Blumer, son of Mr. Blumer-Brodbeck, Glarus, Hon. Member of the Central Society; E. Steinmann, Secrétaire Général, Union Chrétienne de Jeune Gens de Langue Français; and A. Schupbach, a Trustee, and all Members paid the usual silent tribute to the memory of Mr. H. Hoesli, deceased, who was a highly esteemed contributing member.

The Meeting unanimously elected as tellers Messrs. B. Bretscher and A. L. Despond.

The various Annual Reports were duly read, agreed and applauded by all Members present and Mr. M. Paschoud, chairman of the Education Committee, read a letter received from our Head Master, Mr. O. Ph. Masterman-Smith, enclosing a petition to the Society, signed by 31 Day School Pupils, requesting an extension of the classes in high Commercial subjects, which proves that the Day School is fully appreciated by all students.

The Auditors' proposal, seconded by Mr. B. Bretscher, of the adoption of the Accounts, was carried unanimously.

Staehelin, the President of the Society, had made all Members fully understand that nothing could induce him to carry on his office for a further term, and the Meeting had very reluctantly accepted his resignation, Mr. A. Schupbach was elected, with applause, as temporary Chairman. Mr. Schupbach made a few appreciative remarks about the very useful work the President, Mr. A. C. Staehelin, and his Committees had accomplished in the past year.
