### CITY SWISS CLUB. ANNUAL GENERAL MEETING.

The Annual General Meeting, which was preceded by an Ordinary Meeting, was held at Pagan's on April 9th, 49 members and 4 guests being present. Two *membres de passage*, Mr. de Bourg and Mr. Hilfiker, were also present.

After the ordinary business had been disposed of the President, Mr. Max Gerig, declared the Annual General Meeting open and called upon the auditors, Mr. Pfirter and Mr. G. Jenne, to present their report. From this it would appear that the Club is solvent and a hearty vote of thanks was passed to the auditors and to the Treasurer, Mr. de Cintra, for their tireless efforts in looking after the finances of the Club.

The President then read his report, in which he reviewed the events of the past Session. His speech was remarkable for its clarity of thought and neatness of style. In touching terms he referred to the great loss which the Club had sustained by the death of its doyen, Mr. J. Geilinger, who peacefully passed away in his 84th year on March 9th.

The memory of Mr. Geilinger will ever be present amongst those members who frequent the meetings, not only for his gentle kindness of manner but also for the care which he bestowed on his beloved library. May we express the hope that his successor will continue the tradition which he established.

The President then vacated the chair and Mr. P. F. Boehringer was provisionally appointed President while the election of the new Committee took place.

After the votes had been counted the result was declared to be as follows:

Mr. Werner then took the chair and made a short speech in which he expounded his hopes for the coming session.

We were pleased to see that Mr. A. C. Baume, Mr. Boehringer and Mr. G. Marchand were unofficially retained in their respective functions.

Members will be glad to hear that it was decided to again hold the summer meetings at Hendon, when it is hoped that, if the weather be fine, there will be record meetings. Details will be announced later.

The proceedings were brought to a close at 11.45 p.m. ck.

### SWISS RELIEF COMMITTEE, LIVERPOOL

From the report issued by this committee we notice that they have been able to manage their affairs during the past year without asking the members of the Liverpool Swiss Colony for subscriptions. This is a very fortunate state of affairs.

The Committee had an income from interest on investments of £57 0s. 3d. Added to this the fruits of a plus-value conversion of investments, amounting to £16 2s. 11d., and a donation of £12 16s. 9d., the total income was £32 16s. 2d. in excess of the relief disbursements, which amounted to £51 1s. 9d. The funds of the Committee now amount to £1,020.

The Committee say in their report:—"In view of the fact that we are able to meet all our 'calls' out of interest from money invested, we again do not propose to call for any subscriptions in the year before us, but we welcome any donations from anyone who feels inclined to strengthen our funds. The time may, of course, come when 'calls' will exceed our income. If it does, we hope we may rely on the generosity of our subscribers once again."

We hope so, too.
