NOUVELLE SOCIÉTÉ HELVÉTIQUE.

The monthly meeting of the London Group of the Nouvelle Société Helvétique was held on Wednesday evening, the 17th inst., at Swiss House, 34-35, Fitzroy Square, W.1.

One or two interesting subjects had to be dealt with by the meeting, chief amongst these being the scheme to enable Swiss children in England to enjoy a holiday in Switzerland for a nominal sum. Mr. A. Fred Suter, President, advised the meeting that he had got into touch with the "Secrétariat des Suisses à l'Etranger" and "Pro Juventute," and both these institutions in Switzerland had received the proposition with great appreciation and interest. If, therefore, several Swiss families over here can now be sufficiently interested to send their children for a fortnight's holiday amongst the beautiful scenery and health-giving air of Switzerland, the N.S.H. will have the pleasure of seeing this scheme bear fruit this summer. Once the first party of children has enjoyed such a holiday, it is confidently hoped that the scheme will develop with the years and become a regular annual item in the life of the Colony.

Regarding the proposed cinematographic entertainment which is going to be the N.S.H.'s contribution to the 1st of August Fête, Mr. Suter has been successful in securing the promise of the interesting N.S.H. film entitled "A travers la Suisse," for exhibition on the 1st of August. All the arrangements in this connection are now complete.

It was then proposed by Mr. Suter and unanimously agreed to by the meeting that the staff of the Swiss Legation should be elected as temporary honorary members of the London Group.

One or two other points of minor interest were discussed and then the meeting proceeded to the election of the Committee for 1929 and Mr. A. Fred Suter (President and Hon. Treasurer), Mr. C. Campart (Hon. Secretary) and Mr. J. Weber were again unanimously elected.

The meeting closed with a most interesting "causerie" by Mr. W. de Bourg, First Secretary of Legation, on "La peinture Suisse depuis la Renaissance." Mr. de Bourg not only dealt with Swiss artists of world-wide reputation, such as Conrad Witz, Nicholas Manuel, Holbein, Boecklin and Welter, but also with many others of merit and distinction who are not generally known. Mr. de Bourg's excellent exposé not only gave one a clear idea of the development of Swiss Art throughout the centuries, but made one realise very definitely that the size of the country is the last thing to influence the development of artistic life.

Mr. Suter thanked Mr. de Bourg very warmly for his kindness in having agreed to give the Group a "causerie," and assured him how deeply appreciated his having done so was by them all and with what interest they had listened to the many interesting and instructive things he had told them. In conclusion, Mr. Suter said he had great pleasure in welcoming Mr. de Bourg and the other members of the Swiss Legation staff as honorary members of the London Group. The meeting closed with a few words of thanks from Mr. de

Bourg on behalf of the staff of the Swiss Legation and himself to the N.S.H. for having honoured them with the honorary membership.

HOLIDAYS IN SWITZERLAND.

We would advise readers that there are still a number of vacancies open for the holiday party to be arranged by the Nouvelle Société Helvétique in connection with the "Société des Suisses à l'Etranger" and "Pro Juventute."

Monsieur le Rédacteur en Chef.—En 1917 l'Hôpital Français fut doté, grâce à la générosité de Madame de la Panouse et de la Croix Rouge Française, d'une installation de radiologie de premier ordre.

Cette installation a rendu les plus grandes services, mais elle commence à être usée.

D'autre part, pendant les douze années écoulées, de si grands progrès ont été réalisés dans la construction des appareils, que nous nous trouvons aujourd'hui en présence d'une installation qui ne répond plus aux exigences actuelles et en plus ne donne pas à l'opérateur la protection qui est fournie par les instruments plus récents.

On peut dire qu'il y a autant de différence entre une installation moderne et celle de 1917 qu'il y a entre l'automobile d'aujourd'hui et une voiture qui date d'une vingtaine d'années. Or, il y a tout lieu de croire que les perfectionnements des appareils sont maintenant stabilisés.

Nous avons essayé de modifier et de moderniser nos appareils de temps en temps, mais nous avons maintenant la conviction que le moment est venu où il n'est plus possible de faire autrement que d'acheter une nouvelle installation.

Une installation convenable coûterait la somme de £700 au minimum et comme les fonds de l'Hôpital ne permettent pas une telle dépense, il a été décidé de faire un appel spécial en vue d'obtenir l'argent nécessaire.

En conséquence, je vous demanderais de bien vouloir publier cette lettre dans le *Swiss Observer*, car nous recevons un très grand nombre de Suisses nécessiteux à l'Hôpital et nous osons espérer que notre appel ne restera pas sans réponse.

Permettez-moi d'ajouter que les contributions peuvent être envoyées directement à Monsieur le Secrétaire de l'Hôpital Français, 172, Shaftesbury Avenue, W.C., où à moi-même, en précisant que le don est spécialement destiné à l'achat d'une nouvelle installation radiologique.
