The President, Mr. Paschond, when declaring the proceedings open, expressed his delight at seeing many of the older brigade still taking an active part in the Society's functions functions. the "*Times*" wrote about it: "It was possible at Queen's Hall last night, as it usually is when Dr. Felix Weingartner con-ducts, to hear the whole of what the London Symphony Orchestra was playing, not merely a tune here and a blare of brass there, but subjects, counter-subjects, decorations, and figures of ac-companiment, which, incidentally, were played in correct time, triplets as triplets, and doubly dot-ted notes as doubly dotted notes.
