### GOVERNMENT MONOPOLY FOR THE SALE OF SPIRITS.

The result of last Sunday's voting in the much discussed new regulations for the sale of spirits, with special reference to home-distilled 'Schnaps' shows the gratifying result of :--For 490,311; Against 320,635.

The new legislation was accepted by 16 can-tons and 2 half-cantons, and rejected by 3 cantons and 4 half-cantons.

As the new law was recommended by all political parties, apart from the Communists, the result was practically a foregone conclusion, and the referendum has once again clearly shown the opinion of the population. The objection of the legislation, but must be explained as an attempt to destroy all and everything which means the con-stitutional welfare of Switzerland. The Federal Government hopes that the new tax of one franc per litre will yield a yearly revenue of at least 25,000,000 frances, which will be devoted to social welfare work. Whilst the new legislation not only gives the farmers every chance of gaining in the end, it will also improve the quality of table fruit and incidentally educate a large proportion of the population in showing them the value of fresh fruit when consumed as such.

them the value of fresh truit when consumed as such. In 1885 during the 'temperance' movement the slogan was "Down with Schnaps! Drink more Wine and Beer!" This time it sounded different "Down with Schnaps! Enjoy Fruit as Nature offers it to You!" surely a sign that great progress has been made during the last 45 years. Finally it must be remembered that, although statistics clearly prove that our past records in the consumption of alcoholic beverages were a black soot in our social system, it must not be

black spot in our social system, it must not be forgotten that Switzerland's population of not quite 4 million was not alone responsible for the high percentage, as the number of visitors is cal-culated to be about another 4 million per year.

### FOREIGN TRADE IN SWITZERLAND.

FOREIGN TRADE IN SWITZERLAND. Owing to the time of the season, foreign trade is generally slack during the month of January. Concerning the exports the figures relative to watchmaking particularly show a tendency to decline, after the lively business in December. In January 1930, this decrease has been particularly evident as compared with the cor-responding month of the preceding year. The amount of exports and of imports was 354.8 mil-lions against 418,7 millions in December last and 365,7 millions in January 1929. The deficit of

exportation is 61.6 millions. Exports amount to only

70,4 per cent. of Imports. In order to arrive at a more exact comparison

only 70,4 per cent. of Imports. In order to arrive at a more exact comparison in dealing with these figures it is necessary to take into consideration the fall of prices. In January the Imports were 208,2 million francs against 241,3 million in December and 212,1 million in January 1929, which, when disected gives the following figures (in millions of francs) : Foodstuffs: 39 (47 and 43,5); Raw materials for agriculture : 11 (13 and 14); Fuel and heating materials : 17 (18 and 13); Raw materials for industry : 51,5 (58 and 55); Manufactured goods : 47 (49 and 43); Other headings : 43,5 (83 and 44). If we consider the Exports, their total amount in January 1930 was 146,6 millions against 177,4 in December and 153,6 in January 1929 or :— Foodstuffs : 12,3 (11,4 and 12,5); Textile Products : 51,3 (54,5 and 61,7); Machinery and metals : 40,5 (43,5 and 34,6); Watchmaking : 11,6 (36,3 and 14,5); Chemical products, dyes, etc. : 13 (14,1 and 13,8). These figures show that compared with the preceding month the exports also point to an almost general decline with a single insignificant exception. The same may be said in regard to January 1929. Nevertheless, the exception is more important, as the exports of metals, etc. show an increase of nearly 6 millions between these two periods. If we consider the principal purchasers of

Increase of nearly 6 millions between these two periods. If we consider the principal purchasers of Swiss products, we find that the figures relative to each country varied as follows between the three periods alluded to: Germany: 24,8 (30,4 and 28,9); France: 16 (16,7 and 13,9); Italy: 9,7 (12,6 and 11,6); England: 20,3 (22,2 and 21,1); Other European countries: 35,7 (47,6 and 33,3); United States of America: 10,4 (13,1 and 13,2). In December, the decline is general, whereas in comparison with January 1929 two important exceptions are to be noted in favour of Germany and of the collective heading of other European countries. 8.1.T.

**PROGRESS OF SWISS CONCERN.** The Nestlé & Anglo Swiss Condensed Milk Co. has just published its 63rd annual report which bears witness of the strong position and steady progress of this great undertaking. The dividend has been increased from 12 per cent. to 16 per cent. Though the Company has entered into close working arrangements with similar concerns in Germany and Holland the present policy of establishing separate companies in those foreign countries where imports are rendered difficult is being extended. The report also states that the sale of its products in Great Britain meets with considerable competition. LOCAL.
