We understand that the Club has circularised its members regarding the coming Banquet, and it is therefore hardly necessary to enlarge here on the arrangements which have so far been made. ANNUAL GENERAL MEETING.

The Annual General Meeting of the Swiss Choral Society took place on Friday, October 30th at the Swiss Club (Schweizerbund) 74, Charlotte Street, W.1.

The Meeting, which was well attended, was presided over by the Vice-President and Hon. Secretary, Mr. J. Gerber. In opening the deliberations, the chairman extended a hearty welcome to M. de Bourg, first Secretary of Legation, and Hon. Vice-President of the Society. The annual reports of the Secretary and Treasurers, which made very pleasant reading, were confirmed with acclamation and thanks to the respective authors. A special tribute was paid to the Hon. Treasurer, Mr. Ritzmann, for the efficient way the accounts were kept.

A communication by the late President, Mr. F. Conrad, was read, in which he submitted his resignation as President and member of the choir, owing to business reasons. Mr. Gerber thanked the late President, who was present, for the great and untiring services which he had rendered to the Society during his term of office, mentioning, that if, the Swiss Choral Society had reached such a prominent position in the Colony, it was largely due to the incessant work and unceasing efforts of Mr. Conrad. The hearty response which greeted the words of the Chairman was a sure proof how much every member present agreed with this

well deserved tribute. Mr. Conrad thanked the Meeting for their spontaneous appreciation, saying, that when his letter of resignation as member of the Society was sent from Switzerland, he was not then certain whether he would return here, but as he is now once again a resident in this country, he would gladly withdraw his resignation as a member and would support the Society as much as he could; this announcement of the late President was heartily cheered and Mr. Gerber expressed his great satisfaction at seeing this popular member remaining in the fold.

The Chairman then asked M. de Bourg, Hon. Vice-President of the Society, to act as Chairman pro temp. during the elections of the new committee. M. de Bourg, in taking the chair, conveyed the greetings of the Hon. President of the choir, Monsieur C. R. Paravicini, Swiss Minister, to the meeting. He paid a warm tribute to the late President, Mr. Conrad, for the eminent services rendered, and made a moving appeal to all the members, to carry on in the same spirit, with the same patriotic convictions, and to try not only to hold the respected position in the Colony, but even to improve on it, if this was possible.

The newly elected President, Mr. J. Gerber, thanked the Meeting for the honour bestowed on him, in electing him President, and assured the company that he would do his utmost to maintain the good name of the Swiss Choral Society.

After a lengthy discussion in which Messrs. De Bourg, Fischer, Leibfahrt, Sykora, Domeisen, Wyss and Stauffer took place it was decided not to hold a Banquet during this season, but to substitute same with a "Buffet Dance." The committee was empowered to get in touch with the First Avenue Hotel to make the necessary arrangements for this function to be held next February. As to any other social function it was left to the committee to take the necessary steps whenever they might find an opportune occasion. The date for the Annual Concert was fixed for the month of April.

A new music commission, consisting of Messrs. Gerber, Berger, Conrad, Ritzmann, and Fischer was appointed.

Mr. Berger then expressed on behalf of the members of the Society his appreciation for the efficient conductorship of the choir to Mr. Seymour, this short and happy address met with general approval. Mr. Seymour thanked in a few adequate words, saying that it was a pleasure to conduct this choir. The question about the exact time to begin the weekly rehearsals was discussed at length and it was decided to start as hitherto at 7.30 p.m. The President hoped that every member would do his utmost to appear at the time fixed. The Meeting was closed shortly after 11 o'clock p.m.

Then we spent an hour in the beautiful old Cathedral, which has probably the finest Crypt in England and some of the strangest old frescoes and pictures. We were shown round by an excellent guide, who explained everything very lucidly and minutely. In the afternoon we walked through the woods and after one or two little mountaineering feats, we reached Cobham, a quaint old village with a magnificent Church, which contains the finest collection of brasses in the world. We had tea at the historic Leatherbottle Inn, where Dickens so often dined and which is full of pictures of the great novelist and his characters. Finally, at 6 o'clock, we returned to London, after having spent a most enjoyable day.
