The S.M.S. London was founded 42 years ago as a section of the S.K.V. for the purpose of offering its members educational facilities similar to those obtainable in the Swiss sections. From a small beginning the membership gradually grew until it reached 500 odd during the latter years of the late war. For some years before the war already, Day Classes had been arranged on a small scale for young men who came over here to try and find jobs. While looking round for a suitable berth, they could thus usefully employ their spare time by studying English. Then came the difficult period of post-war settlements and re-adjustments, the inability to absorb the sudden flooding of the labour market by the demobilisation of the whole war machinery, and the impossibility of keeping even remotely the promises made to the sons of Great Britain when they were forced to sacrifice their civil life to the needs of forced to sacrifice their civil life to the needs of their Country.

their Country.

The sequel to that chaos was the Aliens' Restrictions Act—and to the unbiassed mind a perfectly logical sequel! But while we are recognizing the need of that Act, we cannot prevent ourselves from regretting the hardships it necessarily imposes upon the young commercial employee who has to find his living in the export trade. We all know that in Swiss export firms the knowledge of German and French is taken for granted and a fair knowledge of English inthe knowledge of German and French is taken for granted and a fair knowledge of English insisted upon, if one is desirous of advancement. When the restrictions deprived our young countrymen of the possibility of coming to England to acquire the knowledge so necessary to them, the S.M.S. was faced with the question "What now?" In 1922 the then President of the Society formed, with the ready help of our Legation and some experienced members, a special committee to examine that question. The result of their labours was the foundation of the S.M.S. Day School.

That innovation, the formation of classes for That innovation, the formation of classes for full-time pupils who could thus learn English in England without in any way infringing the restrictions, will always be a milestone in the history of the London Section of the S.K.V. It will also be a constant reminder of the gratitude we owe to those who solved the puzzle, who used foresight on behalf of our young people at home, and, last but not least, to those men and firms, here, in Switzerland, and in other parts of the world, whose unstinted financial support enabled ambitious dreams to become a reality.

From a lonely teacher waiting in a room on the fifth floor of a Henrietta Street (Covent Garden) building for the first pupils to arrive, the school has developed to an establishment filling the whole of Swiss House and employing 10 teachers. All of them are properly qualified and are British. Although the original plan was, and still is to-day, the teaching of the English language, the lessons offered by the school have been gradually widened in scope until to-day they include sound tuition of purely commercial subjects as well. The highest form has now been divided into a commercial and a literary section, so that the students of that class can follow their own bent. own bent.

All this has not been achieved without ever increasing expenditure and liability. And therein lies the reason for forming the London Section into a Limited Company. Up to now the Society had no legal standing—in fact no existence legally—and the members individually and collectively were entirely and absolutely responsible for any and all of the Society's liabilities. Any one of the members, regardless whether he was on the Committee or one of those very passive "active members," was personally liable with all

Evidently such a state of affairs could not continue any longer. When a Society is committed to expenditure totalling more than £8,000 a year, it is neither fair nor prindent to allow each member to be responsible in full. Under the laws of England the form of a limited liabilities. ity company was the only possible alternative, and this is the remedy applied. Now every member knows exactly what his liability is: The payber knows exactly what his liability is: The payment of his annual contribution and, if the Society should at any time be unable to meet its liabilities, the sum of £1 maximum or such a part of £1 as might be needed to pay all debts in full. Every member is liable for that £1 until the end of 12 months after the date on which he has resigned membership, provided the debt has been incurred while he was a member.

There is no reason why the registration of the Society should make any appreciable difference to the members in general. All they have to do is to take an active interest in all the Society's activities and to ensure that those activities are guided along the right lines by the right reach right people.

SWISS RELIEF COMMITTEE LIVERPOOL.

The Swiss Relief Committee, Liverpool has just issued its report for 1930 and the following details might interest our readers:

Ten persons belonging to 8 different Cantons have been assisted during 1930 and in one case as much as £29 was granted to a compatriot disabled as a result of a serious accident. About half the amount has already been paid back to the Committee and the Balance of one of the large loans made in 1928 has also been refunded. Thus, donations and refunds received in 1930 amounted donations and refunds received in 1930 amounted to £41 5s. 6d.

The income from invested funds amounted to

The income from invested funds amounted to £81 148. 3d. Expenditure on Relief amounted to £81 148. 0d.; expenses total £2 1s. 6d. A grant was made to the Fonds Dimier in London (the object of which is to build a Home for old Swiss in the U.K.) totalling £10.

As compared with last year the funds show a decrease of £7 19s. 9d., but it is hoped to recover further monies paid out in 1930, and therefore the committee does not propose to call for any sub-

committee does not propose to call for any subscriptions for the present year.
