The two editors, Dr. Robert Durrer and Dr. Paul Hilber, have written descriptive text of 290 pages to accompany the 453 illustrations on 405 plates, in which not only the pictures themselves are minutely described and examined, but an attempt is made to trace the history of the development of book illustration in German Switzerland in general and of the illustrated chronicles of the fifteenth century in particular. The proof of the descent of Schilling the chronicler, from an Alsatian family of book illustrators active for several generations, paves the way to interesting revelations and enables us to identify the first artist as the chronicler himself. A detailed family tree affords adequate confirmation. The name of Hans von Arx, called Schlegel, has been suggested for the second painter, a Lucerne artist who is known to have produced two wings now in the Museum at Stans and an altarpiece dated 1513 with the portraits of the donors—a Lucerne couple—and a view of the town. At the beginning of the sixteenth century, Lucerne was an art centre where the young Holbein, sent there in 1517, found artists who had already done excellent work, as, for example, the Master of the Zur Gilgen portrait painted during the first decade of the sixteenth century.

Text and notes, together with a comprehensive index of places and names, give adequate information with regard to the abundance of new material here published and explain the order of the pictures also in respect to their historical significance.

The printing firm Sadag in Geneva has most skilfully made use of its special process "Heliochrome Sadag" and "Heliogravure monochrome" in the reproduction of the chronicle. The coloured plates give a good idea of the general colour scheme of the originals and show clearly the connection of coloured illustration and contemporary glass painting. The publishers, the City Corporation of Lucerne, whose President, Dr. Franz Zeiger, has written the Introduction, made the publication of the book possible by the grant of a generous subsidy, and thus worthily commemorate the entry of Lucerne into the Swiss Confederation.

SWISS GYMNASTIC SOCIETY LONDON.

The Annual General Meeting of the Society took place on Wednesday, the 14th inst., at 74, Charlotte Street, W.1, appropriately enough after gymnastic practice, and was well patronised by the active members. Mr. W. de Bourg, the Hon. Vice-President, represented the Swiss Minister, Honorary President of the Society, and opened the meeting at 10.30 p.m. To the hardened campaigner of general meetings, these gatherings of the Swiss Gymnastic Society, London, must appear very tame affairs, as it is soon obvious that all members pull together and at the same end of the rope for the success of the Society. No wonder, therefore, if both President and Hon. Treasurer were able to disclose a very satisfactory state of affairs in their respective reports.

The Society is in a sound position, and, in spite of the difficult times, continues its activities with enthusiasm and plenty of success. The active members, twenty odd strong, attend practice very regularly, and good work is done, as was proved at the Annual Display, which was patronised by 250 persons in November last. The very able Leader, Mr. H. Knoll, expressed himself very satisfied with the progress made and the work performed. His inspiring example and wide knowledge of gymnastics played a very important part in the year's success. The Ladies' Section has suspended operations for the time being, until more Swiss girls can spare the time for practice; the fact that many of them are unable to get away regularly made suspension inevitable. The Junior Section, comprising fifteen very promising lads from ten to fourteen years, should yield a fair proportion of good gymnasts to the active members' team in a few years time: they are a very promising lot. At long last the Veterans' Section is an accomplished fact, and the participants should greatly benefit from the practice they are putting in every Friday evening at 74, Charlotte Street, W.1. Here is a chance for everybody over 35 years of age! and new members are specially welcome.

The accounts showed a satisfactory state of affairs, with a credit balance of £6.10.0 on the year's working. A hearty vote of thanks was passed to the passive members and supporters who have so nobly helped the Society in the past year.

The Committee was re-elected for 1934 *en bloc*, with the addition of Mr. Marco Motta as second guard of implements, and is composed as follows: President, J. Christen; Vice-President, G. Kummer; Hon. Treasurer, C. L. Schlaepfli; Hon. Secretary, H. Humbel; Leader, H. Knoll; Vice-Leader, C. L. Schlaepfli; Guards of Implements, A. Deubelbeiss, jun., and Marco Motta; Assistant Treasurer, R. Meyer; Assistant Hon. Secretary, R. Nydegger.

The Meeting closed at 11.20 p.m. with a vote of thanks to the Swiss Minister and to Mr. De Bourg for their constant interest in the welfare of the Society.
