le journal qui, d'emblée, a poussé avec le plus d'énergie à la démission immédiate du conseiller fédéral argovien est la "National Zeitung" de Bâle, radicale mais encore plus attachée au maintien du système actuel de la vie chère qu'à son parti. Il y a là quelque chose qui devrait donner l'éveil aux partisans de l'adaptation.

En face de ce problème, la situation — comme on dit en style militaire — est la suivante. Les trois quarts des Suisses, pris individuellement, sont partisans d'une réduction des prix sur toute la ligne. Mais, en tant que membres des associations professionnelles ou économiques, ils en deviennent les adversaires, parce qu'ils entendent être les derniers à en supporter les conséquences. Que les autres commencent ! Et puis, à quoi serviraient les secrétariats généraux, grassement rémunérés, de ces groupements si puissants, s'ils ne recourraient pas de temps à autres aux pratiques de la démagogie ?

Qu'on veuille bien se souvenir des luttes si âpres qui ont marqué les débats des Chambres sur la prixe du blé et sur les appoinements des fonctionnaires, et l'on sera pleinement édifié. L'adaptation des prix n'a de chances d'être agréée que si le gouvernement fédéral en décide le principe le plus tôt possible, tambour battant pour ainsi dire, de façon à lier par avance le successeur de M. Schulthess. Il faut voir les choses telles qu'elles sont et non pas telles qu'on voudrait qu'elles fussent. Ce tableau est malheureusement le seul qui réponde à la réalité.

Avant d'élier le successeur de M. Schulthess, l'on ferait peut-être bien, aussi, d'examiner un point qui ne manque pas d'importance : la division du commerce doit-elle continuer d'être attribuée au département de l'économie publique ? On sait que la loi de 1913 sur la répartition des services prescrit son rattachement au département politique. Après le départ de M. Hoffmann, pour des raisons tant personnelles que d'actualité, elle fut placée de nouveau sous la direction de M. Schulthess. Des arrêtés fédéraux pris tous les cinq ans ont depuis lors sanctionné la prolongation de cette situation provisoire. Mais les raisons invoquées en 1917 auront toutes disparu avec la démission du conseiller fédéral argovien.

Pendant la guerre, en effet, le département politique était surchargé de besogne, tandis que celui de l'industrie et de l'agriculture offrait un champ trop faible à l'activité débordante de son chef. Aujourd'hui, c'est exactement le contraire. Le département politique n'a plus guère de gros problèmes à résoudre, tandis que l'économie publique accapare les problèmes les plus importants qui se posent à l'attention de nos sept sages. Les arguments qui en 1913 militaient en faveur du rattachement de la division du commerce au département politique ont repris leur pleine et entière valeur. De plus, cette mesure faciliterait grandement le choix du successeur de M. Schulthess comme conseiller fédéral et comme chef de département. Elle serait encore de nature à favoriser une évolution de la politique économique du Conseil fédéral en faveur des idées nouvelles.

Il y a là peut-être une issue à une situation, qui, sans elle, risque de rester inextricable. Mais il va de soi que cette réforme si désirable peut jouer un rôle important dans l'élection du nouveau conseiller fédéral, et devrait être décidée sans tarder. Si l'on ne voulait pas s'y résoudre, on risquerait d'embrouiller encore l'écheveau qu'il s'agit de démêler.

NEWS FROM THE COLONY.

SWISS MERCANTILE SOCIETY BANQUET.

In accordance with the still difficult times, the Swiss Societies in London, have curtailed their social functions to a minimum. Apart from the brilliant Annual Banquet of the City Swiss Club, at the Grosvenor House, last November, where again a record attendance was registered, no large Banquet has been held since. Various Societies had their Annual dinners, Cinderella or Fancy Dress Dances, concerts, etc., which were on the whole, fairly well attended.

The next important function in the Colony will be the Annual Banquet and Ball of the Swiss Mercantile Society, which will take place on Saturday, February 23rd, at the Trocadero Restaurant. Monsieur C. R. Paravicini, who is the Honorary President of the Society, will be in the Chair.

The Swiss Mercantile Society has this year, broken with an age long tradition in going to the Trocadero Restaurant. For many years their Annual function has been held at the Midland Hotel, a place which harbours many affectionate memories amongst the older members of the Society; and although one always feels sad to depart from old friends, I consider that the change has been a wise one, and was in accordance with the time. NEW GENERAL MANAGER AT THE RITZ HOTEL.

We extend hearty congratulations to Mr. L. Hilpert, on his appointment as General Manager of the Ritz Hotel, in succession to the late Mr. John S. Walter (who was also a Swiss).

Mr. Hilpert was born at Einsiedeln and hails from a family with a long and distinguished hotel-keeping tradition, his brother Mr. Ernest Hilpert, is assistant manager of the Plaza Hotel, New York.

Mr. Hilpert began his career with alternate seasons as a waiter at the National, Lucerne, and the Cap Martin, Monte Carlo.

In 1913 he went to the Imperial Mentone, and subsequently to the Stephanie, Baden-Baden, and the Grand Bretagne near Lake Como.

In 1914 he was cashier in the restaurant of the Charing Cross Hotel, then head receptionist at the Metropole (London), whence he went to the Ritz, first as head receptionist 14 year ago, and then as assistant manager.
