the note circulation so high in relation to the population as in Switzerland, except in France, and it is possible that this in itself would have an inflationary effect in the event of the abandonment of the gold standard. We must anyhow be prepared for a still greater and more rapid depreciation of our money than the English after the abandonment of the gold standard, and France, Belgium and Holland where the note circulation is also very large in relation to the population are faced with the same fate. In these countries, too, there would be, in all probability, a very great depreciation of the national paper money soon after the abandonment of the gold standard. This would result in a great decrease of the purchasing power of these countries on the world market. The world depression would be accentuated. There would be fresh unrest. Prices would be forced down again on the commodity market, while there would be utter uncertainty on the money and credit market. The uncertainty as to the fate of the currencies and of the prices of goods weighs on the world trade like a mill stone. What is to happen when in the last countries where money could take refuge, monetary safety disappears.

The gold countries can only derive apparent advantage from the abandonment of the gold standard, in view of the fact that they can take part better than before in dumping on the world market. Even now this exchange dumping has become nearly unbearable on the world market and no one who knows the conditions can have any doubt as to the fact that things would be much worse if the gold standard was universally abandoned. Then, all countries can start a fight in the export trade to the last extremity. They can sell lower and lower below their actual costs and saddle the unsuspecting masses of the people at home with the losses of this cut-throat competition. Whether the economic system of the world can recover under such impossible principles, is a matter that can be doubted, in spite of the advice given by the "Economist."

DIE AUSLANDSCHWEIZER IN GEFAHR.

Jhre Probleme — unser Aufgaben.

Dreihundertdreisigtausend Schweizer leben heute im Ausland. Dreihundertdreisigtausend Inhaber des Schweizerbürgersrechts und eines Schweizerpasses. Manch ein anderer Schweizer mag ausserdem noch in diesem und jenem Erdenwinkel sich der konsularischen Immatrikulation, der Militärsteuer und der statistischen Erfassung absichtlich oder aus Nachlässigkeit entziehen. Und viele Frauen, die durch Heirat mit einem Ausländer ihr altes Bürgerrecht verloren haben, sind ihrer Heimat im Herzen so treu geblieben wie irgend einer. — Heute lebt der zehnte Teil aller Schweizer im Auslande!

Es gibt wenige Völker der Erde, die zu einem so hohen Prozentsatz wie das Schweizervolk auf fremdem Staatsgebiet wohnen. Mehr als die Bevölkerung des ganzen Kantons Waadt! Die Hälfte aller Einwohner des Kantons Bern! Und doch steht das Interesse des Inlandschweizer an seinen Mitbürgern in der Fremde in keinem Verhältnis zur Bedeutung des Auslandschweizertums. Da haben schon die Italiener kommen müssen mit ihren intensiven Fürsorge für die Angehörigen in andern Ländern und die Deutschen mit ihrer politischen, volks- und rassekundlichen Propagierung des "Deutschtums jenseits der Reichsgrenzen," bis auch bei uns steh' weitere Kreise darin erinnerten, dass für das Schweizertum im Auslande mehr getan werden sollte.

Die hohe Zahl macht die Auslandschweizerfrage heute nicht dringender als bisher; denn diese Zahl war in früheren Jahren noch höher. Es ist die besonders schwierige Lage, materiell und geistig, in der sich die Auslandschweizer heute befinden; was aufthoren macht. Schweizer passt auf: das Auslandschweizertum ist in Gefahr!

Es ist in Gefahr, im Drange

Nationalistischer Ströme

des Wohnsitzvolkes zu vergessen, dass das Schweizertum nicht auf Rasse, Blut und Boden beruht, sondern auf der politischen Idee unserer Eidgenossenschaft, und dass es nur mit den Waffen des Gerüsts verteidigt werden kann. Es ist in Gefahr, die Grundgedanken unserer eidgenössischen Existenz aus den Augen zu verlieren. Und es ist deswegen in Gefahr, sich selbst zu verlieren in der völkischen Aufwallung eines kulturell und sprachlich verwandten Auslandes. Wir im Landewohnenden Schweizer haben gegen alle Annässungen von draussen den Schutz unserer politischen Grenze; der Auslandschweizer aber, der im-nationalistisch erregten Ausland selber lebt, hat ihm nicht seine tägliche Sorge ist das Standhalten unter den Hammerschlägen einer antidemokratischen und rassenbedingten staatlichen Propaganda.

Der heimattreue Auslandschweizer ist aber in Gefahr, auch seine wirtschaftliche Existenz zu verlieren. Viele Auslandschweizer wollen heute zurückwandern. Viele fordern Unterstützung. Viele erliegen einer Übermacht und verzichten auf ihr Schweizertum. Man merkt davon etwas im Schweizervolk. Man muss noch mehr merken. Wir diffunden keine Gelegenheit verpassen, jeden der uns zuhören oder lesen will, darum aufmerksam zu machen, dass die Auslandschweizerfrage als Problem von höchster staatspolitischer Bedeutung des gemeinschaftlichen Interesses.
