THE STOCK EXCHANGE OF ZURICH. (By Leu and Co.'s Bank Limited, Zurich.)

Zurich, December 1st, 1936. The month of November opened most en-couragingly. First because the technical struc-ture of the Zurich stock exchange favoured higher prices and secondly because the Roosevelt-re-elec-tion was greeted in Wall Street bullishly and stimulated at the same time European markets. A continued influx of capital into Switzerland which was looking for investments by all means, created a demand for almost everything. Towards the middle of this past month how.

Towards the middle of this past month, how-ever, the outlook turned more clouded, partly be-cause new regulations in restraint of speculation in American markets caused a set back in New York and disappointed here, and partly because the situation in Spain developed in a way that increased fears of serious troubles in Europe and made selling advisable. made selling advisable.

made sening advisable. During the upward-movement banking shares and also insurance stocks ranged at the top. Trust companies profited widely, but as their character is more speculative the reaction that followed later on was more sudden. Few stocks only were able to maintain their new heights, while most others consolidated finally on a lower basis which, however, is still well above beginning prices

Stimulated by rumours of merger Elek-trowerte A.G. and Elektrizitäts- und Verkehrstrowerte A.g. and Electrizitats' and version gesellschaft profited considerably. The former advancing as follows: 239-280-248 and the latter likewise from 200 to 242 to 224 respectively. Almost as an exception Motor-Columbus quotes now some 30 to 40 points lower than at first, the result of a statement by the president of this company saying that in spite of devaluation the com-pany's assets have not appreciated enough to do away with increased book-losses. Among the foreign investments Hispano advanced as far as 1420; loosing ground, however, lately, same quote approximately 1,360. Royal Dutch very firm for a while gave way on the fact that no interim dividend was going to be distributed. Since a few days, however, prices are rising again.

Swiss industrials were well in demand in the first part of the month and developped weaker

Very wide fluctuations noticed Nestlé in con-nection with a re-organisation and a distribution of some sort of stock bonus (1,154-1,199-1,100-1,116).

The bond market showed a similar unsteady development. Swiss Governmentals and Federal railways advanced further and 3½% C.F.F. Series A-K sold for more than 101%. General uncer-tainty, however, reduced prices here as well as elsewhere. Among the cantonal issues those of the Canton of Neuchâtel were able to regain several points after a relance and those of these the Canton of Neuchitel were able to regain several points after a relapse and those of the Canton of Geneva rose sharply upon the electoral victory of the liberal parties over the socialists and communists last Sunday. Foreign bonds first well disposed, naturally suffered most by the gloomy political outlook in Europe. Especially French securities never seem to be able to hold their gains over any length of time, while Italian ones lost several points upon the latest reports over the Spanish civil war.

The strictly commercial aims of the Fair can already be clearly seen in the careful grouping the exhibits. The 21 regular groups h remained unchanged; but on the occasion of twentieth anniversary eight special fairs w held. The number of exhibitors was 1,248 (1, 10007) twentieth anniversary eight special rans , held. The number of exhibitors was 1,248 (1, in 1935), and the exhibition space occupied 16, square metres (16,183 in 1935). The 7 exhibit halls were utilised to the last square metre space. In such difficult times this record part pation is a proof of the confidence enjoyed by Fair. The many industrial innovations and i provements exhibited are characteristic.

provements exhibited are characteristic. The attendance of visitors at the Fair w very large. Altogether 119,187 buyers' tickets a 31' 745 ordinary entrance tickets were issued. spite of the many difficulties in the way of traw ling, the number of visitors from other countr did not diminish. According to statistics the were 1,546 foreign buyers coming from 35 con tries (1,558 in 1935). It may be noted in this co-nection that 18 European states offer reduced rs way fares to those visiting the Swiss Industr Fair. In order to deal with the enormous tra occasioned by the Fair the Swiss Federal R: ways ran 136 special trains. Motor car traffic the Fair was likewise increased. the Fair was likewise increased.
