Under this heading we published in 1936 a series of appeals in this paper, asking our compatriots for help for our brethren in Spain. The response was a splendid one, within three months we were able to send a cheque to the Relief Committee, amounting to £513 9s. 10d.

Our example was followed by a number of Our example was followed by a number of Swiss Colonies abroad and the result of the various collections greatly helped our comrades, who through no fault of their own had to under-go many privations and great hardships.

A month ago, a compatriot of ours, Mr. Charles Strubin, of Messrs, Chas. Strubin & Co., Ltd., 27, Creechurch Lane, E.C., on his own initiative sent the following consignment to our compatriots in Spain:

1,000 tins of sweetened milk

1,000 lbs. of Coffee

10,000 cigarettes

1.000 packets of toilet soap.

This "beau geste" has been greatly appreciated by our countrymen in this unhappy land, and we are very pleased to publish herewith two letters addressed to Mr. Strubin by the Swiss Authorities in Barcelona. We too express our sincere thanks to Mr. Strubin for this really patriotic act.

A meeting of the Swiss Sports and Garden Party Committee and Delegates was Swiss House on Thursday, October 6th.

The President, Mr. R. de Cintra, was in the Chair and the meeting was well attended

The accounts for the year under review were dealt with and showed a surplus sufficiently large to cover the deficit of the previous Swiss Sports meeting.

The Committee was unanimously re-elected for another term of office.

A proposal to revert to the original number A proposal to revert to the original number of three Delegates for each Society instead of two was defeated by a large majority. The point was, however, stressed that the various Societies should only depute such Delegates who were really interested in sports and willing to attend the Committee meetings regularly as well as to render assistance at the Sports Meeting itself. It was found that the brunt of the work rested with just a few staunch members who could well do with some additional help.

The last Sports Meeting, despite the in-clement weather, was a great success both from the social as well as the financial point of view. The change of venue and the additional attractions proved a great incentive. Encouraged by the support of the Swiss Colony at the last Sports Meeting, the Committee decided to book the ground at the Duke of York's Headquarters, Chelsea, for July 1939.

The Committee thus hopes that the Swiss Sports will again become an outstanding function in the social activities of the Swiss Colony and no efforts will be spared to that end.

NOUVELLE SOCIETE HELVETIQUE.

The London Group of the Nouvelle Société The London Group of the Nouvelle Société Helvétique resumed on the 23rd September, at the Foyer Suisse, its activities for the coming winter and the Chairman, Mr. A. F. Suter, expressed his pleasure at being able to greet a large circle of old and new members, in addition to a good many friends of the Society. In addition to the promise of a most interesting talk from an aminent compacting other factors, we feel had eminent compatriot, other factors, we feel, had their share in bringing together such a strong gathering. The desire, for one, of greeting old friends after the summer vacation, but above all the wish to close the ranks as the immediate future looked so uncertain. True the crisis had not then expensed the arrivages which the fall. not then assumed the seriousness which the fol-lowing week was to bring, but the portents were ominous enough to induce anyone to seek comfort and strength in the company of fellow country-

At the conclusion of an informal supper, which is always such a pleasant feature of the Society's gatherings, the current business of the Group was disposed of in a minimum of time. The Chairman informed the meeting that in order to bring our winter Film Shows in line with modern requirements, it was proposed to hold future shows in a hall affording the necessary facilities for the presentation of sound films. Arrangements were being made to secure Kingssary facilities for the presentation of sound films. Arrangements were being made to secure Kingsway Hall and the meeting gave its wholehearted support to the suggestion, which will doubtless be equally welcomed by all those who have derived enjoyment from past Film Shows. The hope was expressed that contributions would in due course be forthcoming from the Colony to cover the greatly increased expenses which this new departure will involve.

The Chairman then introduced the speaker for the evening, in the person of Mr. Hanns Vischer. Although a stranger to most of those present, Mr. Vischer soon succeeded through his natural eloquence in making friends with his audience. "The Swiss and the Empire" was the subject of the causerie and no one could have the subject of the causerie and no one could have treated this theme in a more interesting manner than Mr. Vischer, who besides being a Swiss has the added advantage of being attached to the British Colonial Office. His association with that Office dates back to 1900, when fresh from Cambridge — and his "Rekrutenschule" in Liestal — he was sent to Nigeria in charge of a military expedition against a cannibal tribe a military expedition against a cannibal tribe which had the reputation of attacking peaceful trading caravans. The speaker related how a fourteen days battle was fought, in which poisoned arrows were used from one side and fire-arms from the other; after delicate negotiations, led by our compatriot, peace was secured and he remained alone with the tribe to supervise the making of roads imposed upon them as a punishment for their past misdeeds. The British Government were quick to appreciate his high qualities as an organiser and coloniser and Mr. Vischer worked in different parts of Africa until 1923, when he was recalled. Eventually, he was asked to report on the possibilities of emigration to the Empire and the conclusions of our compatriot on this all important subject may be summed up as follows:

The British Empire has room for young men endowed with the necessary qualities, i.e. a singleness of purpose and the will power to carry it through. But above all, work among the natives requires, besides a keen sense of humour, a strong belief that these men of another race, given equal opportunities, can evolve on the same lines as ourselves. The old conception that the success of colonisation depends on the prestige of the white man is out of date and future efforts must be based on mutual understanding between must be based on mutual understanding between white and black men. The secret of Empire building lies in bringing the natives to a standard building lies in bringing the natives to a standard of living, which will tend to make them faithful to the King and the Home Country, and this is not to be achieved by force but by sentiment. Emigration is not to be considered simply as a means to relieve a nation of those who cannot find work at home or again to provide for the individual an occasion to make money in as short a time as possible and to return to boast. Emigration must be looked upon as a duty to one's country and a service to fellow men; it consists in imparting to others the benefits received at in imparting to others the benefits received at home, either in the form of State education or from traditions inherited. In this respect, the Swiss are particularly well favoured and Mr. Vischer emphasised how his own Swiss upbringing had helped him in his work.

At the outset of his address the speaker had At the outset of his address the speaker had made a short review of Swiss emigration to the British Empire through the ages, mentioning here and there the names of Swiss who had particularly distinguished themselves in their respective fields of activity; one heard of such famous names as De Pury, De Watteyille, and of the more recent work done by the Basle Mission, the Baldegger Schwestern and other organisations.
