#### LETTER FROM SWITZERLAND.

The Economic Situation in 1938.

In 1938 Switzerland's imports totalled approximately 1,000 million Swiss francs; exports having amounted to 1,317 millions her trade balance showed a deficit of 290 millions against 520 in 1937. The position may be considered as favourable because this is the lowest figure registered since 1922, after which year the deficit is recorded and hereby the trade in the same property of the same property and the same prop increased each year to attain a maximum of approximately 962 millions in 1932.

In 1938 Swiss imports decreased by 200 million francs as compared with 1937. This drop is partly due to the fall in world market prices, which was 6.2% in quantity and 11.1% in value. Exports, on the other hand, increased by 30 million francs, although the position is not the same for all industries. The position is more favourable for the metal industry than for the textile industry. A marked rise in exports is noted for machinery, vehicles, instruments and apparatus, aluminium. Exports of chemicals, cheese, condensed milk, chocolate, watches are also on the aluminium. Exports of chemicals, cheese, condensed milk, chocolate, watches are also on the upward trend.

The extraordinary liquidity which characterised the Swiss money market since the devaluation of the franc in September 1936, was barely affected by the international tension of 1938. anected by the international tension of 1936. Liquid assets remained so plentiful that the discount rate, outside banking establishments, was maintained at 1% viz., on the 1937 level. There was no necessity for the National Bank to increase the official discount rate  $(1\frac{1}{2}\%)$  or that of security loans. A marked tendency prevailed on the capital market to lower rates of interest in favour of long-term loans. By way of compensa-tion the rates for the bonds have increased.

The positon of the labour market shows a slight improvement. Following a recovery in building, the average number of applications for employment dropped to 65,000 against 71,000 in 1937 and 93,000 in 1936.

The number of strikes was insignificant and settlement was reached in almost all the disputes — very few in number — which arose in connection with collective agreements.

Cost of living decreased during 1938, the index number at the end of December being 137 against 138 in 1937 (1914=100). The wholesale price index also dropped (106 at the end of 1938) against 109.6 at the end of 1937).

The Swiss tourist trade was not wholly unaffected by the recent international tension. The number of passengers travelling on Swiss trains remained, however, the same as for the preceding year. In view of the opening in Zurich on May 6th, 1939, of the Swiss National Exhibition, the influx of foreign visitors will undoubtedly be much greater than ordinarily.

It may be concluded that, on the whole, 1938 was not too unfavourable a year for Switzerland. Since the internal economy of every country depends largely on the political situation, it can only be hoped that 1939 will bring the solution of present difficulties so as to allow economic activity to develop freely.

The Swiss husband can usually look at the world through rose coloured glasses if he opens a bottle of the wine of his country and smoke a "Stumpe" at whatever hour of the night he returns to his abode from one or other of his social gatherings, and no matter how well he has fed solidly or liquidly. His wife will have retired as usual only trusting that the coming snores will not disturb her rest and

thus prevent her rising early enough to prepare his breakfast, clean his boots, and brush his clothes preparatory to his departing next morn-

If ever a Swiss husband brought his wife a cup of tea in bed in the mornings, one of two things are bound to happen: either she would faint or come to the conclusion her husband wanted something.
