### FROM OUR POSTBAG.

4th April, 1941.

Dear Sir,

#### *News at Random.*

Having in my capacity as "the man in the street" tilted at the Federal Government in your number of the 22nd March, it behoves me to-day to put on record that the action of the Federal Government was correct.

It appears from the report in the Neue Zürcher Zeitung of the 16th January that the surrender of the French War Equipment to the German Reich was taken at the express desire of the French Government: it took place in the name and for account of the French Government.

An exception was made with regard to the horses which were returned to France because French agriculture was sadly in need of them.

The "man in the street" is glad to find himself in complete agreement with the Federal Government.

The fact, to his regret, remains that the German Reich has acquired a valuable addition to their war equipment.

It is just in these times that the need for your paper is most felt, and thus your patriotic decision to keep it in being is all the more appreciated by the colony.

You ask me how members of my Society have fared in recent air raids? Most of them have gone unscathed, but some have been the victims. You have already reported in your columns the destruction of Paganini's, which in recent years had become the very heart of the life of the Ticinese community, whilst its proprietors, Signora Linda and Sig. Arturo Meschini, were our staunchest supporters. Others of our members have had their places of business demolished, or their homes. In one case, our member's son was killed.

To alleviate partly the hardships caused, we have added an "air raid benefit," of which a number of members have already availed themselves. The purpose being to get help to the victim quickly and thus make up for any delay in official arrangements.

With best wishes for the future to you, and to the "Swiss Observer."
