### THE SWISS BENEVOLENT SOCIETY.

The quarterly meeting of the Swiss Benevolent Society was held at the Swiss Home, 31, Conway Street, W.1, on Monday, 12th November, 1945. The President was in the chair. The usual routine matters were first dealt with and the Hon. Treasurer then presented the accounts made up to the end of September. An unusually large amount had been spent on casual relief, but this was only to be expected after the end of the war. The weekly allowances were increased and the fuel allowances had to be paid for a full month longer than most years owing to the cold spring. The Hon. Treasurer pointed out that one of the reasons why the Society was short of cash at the end of the first nine months of the year was that so many of the annual subscriptions were still outstanding.

Several repatriations have taken place and three pensioners have died. Two new people were elected in their place, one a woman of 86. The Committee accepted with regret the resignation of Mme. Chatelain, who had permanently returned to Switzerland. Mr. and Mrs. Bachofen were proposed as new members of the Committee and duly elected.

In his report the Secretary mentioned that eight Swiss, former members of a Swiss firm at Singapore, who had suffered under the Japanese, arrived in London recently en route to Switzerland. Accommodation had to be found for them, by no means an easy task these days. Fortunately, members of the Swiss colony

kindly offered their hospitality, although these refugees had no ration cards.
