SCHWEIZERBUND (SWISS CLUB).

The 118th Half Yearly General Meeting held on February 9th, at 74, Charlotte Street, was well patronized. The Chairman, Mr. H. Mueller, after welcoming the gathering, especially our Trustees, Messrs. R. Keller and J. Joerin, opened the meeting at 4 p.m. with a short *résumé* of the Club's business during the six months ended December 31st, 1945, dwelling not only on the bright spots, but also pointing out the many difficulties which had to be tackled by the Committee with a view to improve the amenities of the Club so as to attract more of our compatriots. To a large degree these endeavours bore fruit, mainly through the appointment of a new Steward and Stewardess, Mr. and Mrs. F. Wyss, who at all times courteous and painstaking as well as fully qualified to satisfy the inner man, particularly the Swiss palate, well deserved the Chairman's congratulations and the members' hearty applause. The news of this appointment and that really excellent luncheons and dinners were to be had at the Schweizerbund soon spread in the Colony. Consequently many old Swiss members and friends re-joined our ranks. Furthermore, the Swiss Male Choir again set up its headquarters at 74, Charlotte Street, a fact which was loudly acclaimed by the meeting. The Chairman thanked his fellow-officers for their wholehearted collaboration during his term of office, and then announced his and their resignation, but declared that all were willing to serve again if re-elected. During the election of the President, Mr. Joerin ably officiated as Chairman *pro tem*. His residence in the chair was, however, of very short duration, as Mr. H. Mueller's re-election occupied only minutes. The election of officers terminated with the following results: Chairman: Mr. H. Mueller (re-elected); Vice-Chairman: Mr. P. Stoeri (re-elected); Secretary: Mr. P. E. Imhof (re-elected); Treasurers: Messrs. W. Hausermann and F. Studer (re-elected); Auditors: Messrs. J. M. Trepp and S. Croset (re-elected); Committee: M. Bachofer, A. Bussert, A. Greder, E. Rikli (re-elected), and J. Schrier and H. Yanischek (newly elected).

Balance Sheet. The Auditors reported very favourably on the Club's affairs and invited criticism of the Balance Sheet. None were, however, forthcoming, and the balance sheet was accepted with unanimous satisfaction.

A few minor items were then disposed of, and the meeting terminated at 6 p.m. *Sec.*
