FROM THE SWISS LEGATION.

We have received the following communication from the Swiss Legation in London:

Dear Sir,

Following Monsieur Ruegger's intervention, "Swissair" have had the courtesy to place at the disposal of the Swiss Legation 15 places on the planes leaving London for Basle and Zürich every Sunday in September, that is on the 1st, 8th, 15th, 22nd and 29th. These places are to be allocated to *Swiss nationals whose state of health* make it necessary for them to go to Switzerland by air in order to recuperate or undergo treatment.

If you should know of any deserving cases, would you be so kind as to inform the persons concerned that on application to the air priorities section of this Legation they will receive a priority docket entitling them to book their passage to Switzerland at the British Overseas Airways Corporation, Airways Terminal.
