Dear Sir,

It will, no doubt, be of interest to your readers to hear, that on the initiative of Pasteur M. Pradervand, undertaken some time ago, a few of Mr. & Mrs. René Marchand's friends have subscribed the handsome sum of £1,250 towards the costs of re-building the Swiss Church in Endell Street.

The above mentioned donations are in addition to the official and general appeal made by the Consistoire of the Swiss Church for the building of a spacious room to be used by our young compatriots for religious and social purposes.

A suggestion has been made, that a bronze tablet, in memory of Pilot Officer Roy Marchand, and the other Swiss, belonging to the Church, who died during the second world war should be placed in this room.

I take this opportunity to recall that Pilot Officer Roy Marchand, was a member of the Swiss Church, his parents were married there and he himself was christened at Endell Street by the late Pasteur R. Hoffmann-de Visme. Pasteur M. Pradervand attended at his wedding and also officiated at his funeral. Roy's baby daughter Carole was also baptised in the Swiss Church.
