According to the reports so far published in the press, the Swiss Hoteliers have, once again, managed to get what they wanted, *i.e.*, the relaxation of the ban on foreign travel and British tourists will be able to go to Switzerland again and enjoy themselves as best they can on £35.

While they will certainly receive a warm welcome in Switzerland, it seems strange that the Swiss Government should be so anxious to foster the tourist traffic at the expense of the export industry. It has, in fact, already been openly admitted that this agreement with the Board of Trade and Treasury has only been arrived at after the Swiss Trade Delegation had given an undertaking to limit Swiss Exports to the Sterling area.

The Hotel Trade is no doubt an important part of our Swiss economy, but surely not *the* most important one?

Many members of the Swiss Colony in Great Britain have for years been hoping that Swiss Goods would, some day, be allowed to come in again. In some trades (not only in the watch trade) British buyers are clamouring for Swiss Goods but at this rate they will have to wait till Doomsday, for, to the powers that be in Switzerland, tourists apparently come first! Why?
