## WALTER EICHENBERGER †.

We deeply regret to announce the death of Mr. Walter Eichenberger, a former Deputy Manager of the Swiss Bank Corporation, London, which ocurred on Sunday, September 11th, at his home "Oakilene," Redden Court Road, Harold Wood, Essex.

Mr. Walter Eichenberger was born on the 8th May, 1871, at Burg in the Canton of Argovie. Already as a young man, he showed himself a brilliant scholar. After passing through the local schools and the Bezirksschule in Reinach, he felt an early interest in acquiring foreign languages; consequently, he spent a considerable time in Neuchâtel and after a stay in Genoa, Italy, he came to England which subsequently proved to be his second home.

In July, 1898, he entered the then newly founded Swiss Bank Corporation in the City, where he was put in charge of the Bookkeeping. In the course of some years, he was promoted to the post of Sub-Manager and on the 1st January, 1925, to the post of Deputy Manager of this institution.

His advice, as an authority on banking matters, was often sought for on account of his vast experience. Many of his compatriots who in their young days entered the service of the Swiss Bank Corporation remember him always with gratitude for the numerous kindnesses he extended to them during their stay in London.

After 38 years of faithful service, he retired at the end of 1936 and many were the friends who, although regretting his departure, wished him many years of happiness in his well-earned rest.

In his private life, he was essentially a family man. Whilst he was not often seen at the official functions in the Swiss Colony, his home was a place where his friends were always sure of receiving a generous welcome.

One organisation in which he took a personal interest was the Swiss Mercantile Society to which he was elected a Trustee; in that capacity, he helped greatly to further the Society's scholastic activities, which, owing to their importance, was greatly appreciated.

It was widely known that his helping and generous hand was often extended to needy cases, and many testimonies to his benevolence have come not only from his native country, Switzerland, but also from England, his adopted country.

To his widow goes out the sympathy of his numerous friends who have loved and respected him.

His life was work, and love and may God give him eternal peace.


