We therefore make a new and earnest appeal to all our readers to induce their friends, who are not as yet on our mailing list, to subscribe to the "Swiss Observer." (If everyone of our actual subscribers would enrol only *one* new one, all our troubles would be at an end, and we could then look into the future with confidence.) Whilst we have made heavy sacrifices in the past, we cannot go on indefinitely doing so, and if this publication is to go on, we must get increased support.

The Editor and Publishers take this opportunity to express their sincere thanks to all those who so kindly have sent us a little extra over and above their subscriptions, which has been a great help; special thanks are also due to our advertisers, who have given us their constant support, without which we could not have carried on.

It is our endeavour to continue and to improve this paper, which from the many testimonials received, seems to be appreciated, but, we repeat, that unless we get a more active support in the near future, from the members of the Colony, we shall be reluctantly compelled to discontinue our activities.
