## **ANGLO-SWISS SOCIETY**

In 1948 the Anglo-Swiss Society was founded in London for the purpose of maintaining and developing the existing friendship between the British and Swiss peoples, to foster a closer unity to the mutual advantage of the two nations, and to promote social and cultural relations between Great Britain and Switzerland. The activities of the Society are strictly non-political.

The Society is a British Society and works in close and friendly co-operation with the Swiss-British Society in Switzerland.

It functions by means of Receptions, Luncheons and Dinners in celebration of special occasions, in honour of distinguished guests, and in order to provide regular opportunities for the members to meet. It is proposed also to arrange other activities such as Exhibitions, Films, Lectures and Discussions on art, literature, music, science, discovery, travel and social life in Switzerland.

Members receive a monthly circular giving details of future functions and other information.

### **MEMBERSHIP AND SUBSCRIPTION**

Membership of the Society is open to all persons interested in the objects of the Society, subject to election by the Executive Committee.

The Annual Subscription is ONE POUND covering 12 months membership, and an Application Form is attached.
