JOURNEE DES SUISSES A L'ETRANGER.

September 1st — 3rd at Lausanne.

Wishes and suggestions to be submitted.

This year's conference of the Swiss abroad is taking place at Lausanne on September 1st to September 3rd, 1950. All the Societies in the Colony are invited to submit suggestions and requests for the Agenda as early as possible, so that a suitable working-programme can be drawn up by the Secrétariat des Suisses à l'Etranger.

As in previous years the London Group of the Nouvelle Société Helvétique has called an Open Meeting to discuss what problems and what requests our Colony ought to raise at Lausanne. This being the only opportunity for the Swiss abroad to make their views and demands known in an effective manner, it is particularly regretful that only very few compatriots attended the Meeting.

The indifference thus manifested by the Colony is the more remarkable as there have been several concrete proofs, showing that the Colony's representations do not remain entirely unheard. However, there were enough present to ensure an adequate discussion of some of the questions raised, with the assistance both of Dr. Umbricht and M. Clottu, Commercial and Social Attachés of the Legation. A list of the questions suggested for the Journée des Suisses à l'Etranger is appended herewith:—

- (1) Financial and Economic questions:
 - (a) Double taxation with special regard for Old Age-Pensioners retiring to Switzerland;
 - (b) Old Age Assurance;
 - (c) Facilities to take out additional Assurances in Switzerland;
 - (d) Military tax;
 - (e) Appeal to Swiss firms in favour of Swiss representatives abroad.
- (2) Political:
 - (a) Voting for Swiss abroad when in Switzerland;
 - (b) Election of own representatives in Parliament;
 - (c) New Citizenship-Law.
- (3) General:
 - (a) Ways and means for asserting the views and requests of the Swiss abroad.

All Swiss in England are invited to communicate to the Secrétariat des Suisses à l'Etranger, Wallgasse 2, Berne, or the Hon. Secretary of the Nouvelle Société Helvétique, London Group, 35, Fitzroy Square, W.1, any additional suggestions or representations regarding the Agenda for the Journée. It is very much to be hoped that all the Societies in our Colony will nominate representatives for the Journée, so as to give the Delegation from England an increasing influence in the Councils of this organisation.
