## LONDON SWISS PHILATELIC SOCIETY.

#### Annual General Meeting, at the Glendower Hotel, Glendower Place, S.W.1, on Saturday, January 27, 1951.

When the last "Auld Lang Syne" was sung at the conclusion of the Anglo-Swiss Society's Banquet, on December 11th, 1950, at the Dorchester Hotel, I was looking forward to a little rest, after a somewhat hectic three months of banquetting and dancing.

The respite from "official" duties, I am sorry to say, did not last very long, as we are entering now the season of Annual General Meetings.

To make these more attractive to the members, most of these meetings are combined with either a luncheon or a dinner, which is not a bad idea, as this is more conducive to congeniality, and many a one, who intended to "kick up a dust" decided, after a glass or two of "Neuchâtel" to "keep the peace."

Streit, President, W. Burren, Vice-President, W. Haworth, Secretary and Editor of the "Bulletin", G. Wahl, Treasurer, E. M. Huber, Packet Superintendent, and Messrs. Pachoud, Becken and Waloff.

Finally Mr. Streit expressed his warm appreciation to Mr. and Mrs. A. Schmid for their excellent catering arrangements. The President's humorous address was heartily cheered.

Mr. A. Stauffer, on behalf of the guests, thanked the Society for the generous hospitality which had been extended to them.

The President, Mr. F. Streit amidst acclamation was presented with a silver cup for having won this year's Competition.

As usual, a tombola for the benefit of the Swiss Benevolent Society was held, with very attractive prizes (this time I was not lucky), yielding the sum of £35, a really splendid result, which Mr. M. Roethlisberger, of the Swiss Benevolent Society acknowledged with hearty thanks. An auction then took place for the benefit of the victims of Swiss avalanches and the amount of £10 was collected, which clearly shows that the members of the London Swiss Philatelic Society are not only fine, but generous fellows. Mr. G. Wahl was in charge of the tombola and the auction and the splendid results are greatly due to his efforts.

This 8th Annual General Meeting and Luncheon came to a close soon after 6 p.m., and everyone left the Glendower Hotel with the satisfaction of having spent a most enjoyable afternoon amongst good friends.
